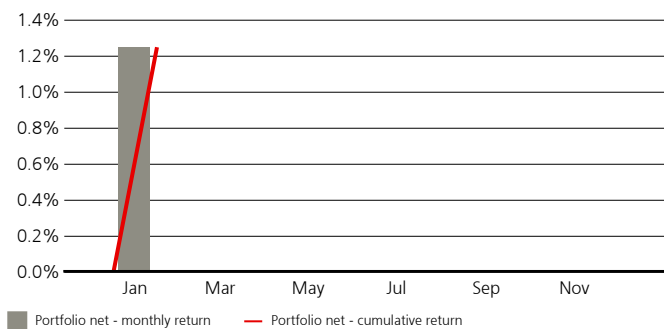
## Investment Policy

The aim is to generate capital gains and asset growth on the basis of a conservative risk profile in Swiss francs. The active management is based on the tactical decisions of our investment committees and invests exclusively in a universe of traditional asset classes. An equity component of no more than 25% and clearly defined risk parameters are intended to generate a return that is in line with financial market cycles. The fund comprises mainly individual investments and the majority of the securities are from Swiss issuers. The investments are usually hedged 100% in Swiss francs. The fund observes the investment regulations in accordance with article 7 VBVV para. 1 (Ordinance on asset management under a guardianship or legal custodian).

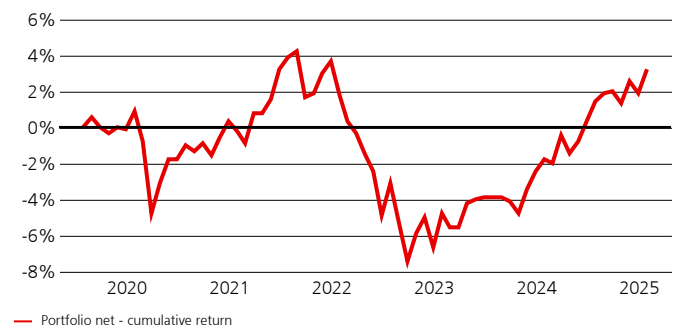
## Performance overview - monthly & cumulative

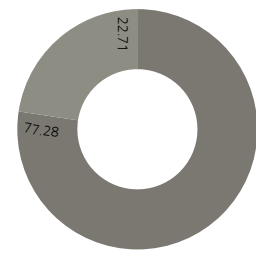

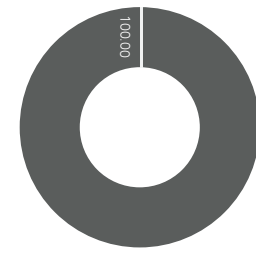
By asset class in % of total economic exposure

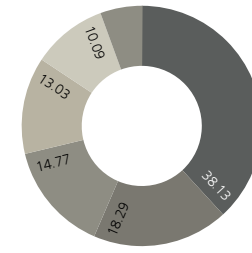
By instrument currency in % of total economic exposure (after currency hedging)

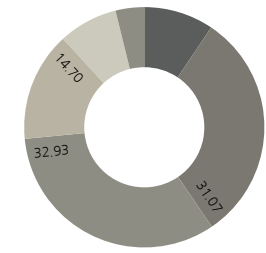
By type in % of bond economic exposure

**Performance commentary**

After a lacklustre start to the year, equity markets rallied on the notion that Trump's trade war might not be waged against the whole world after all. Europe, and particularly Switzerland, outperformed, pricing in an increased likelihood of a ceasefire in Ukraine. As opposed to European or US fixed-income markets, the Swiss yield curve is slightly higher, and bonds have underperformed accordingly.

**Market comments**

Since Donald Trump won the US presidential election and the Republicans gained control of Congress, long-end government bond yields have increased, the dollar has strengthened and equity markets have become more volatile. Tariffs are the area where the president has the most unilateral authority to alter the market consensus around continued growth and receding inflation. At least until the end of January, the world has been spared the most extreme measures, such as universal tariffs on all US imports, and markets reacted with a relief rally across asset classes. Central bank activity remained within expectations, with the Fed pausing rate cuts and the ECB cutting by 25bp. The release of Chinese start-up DeepSeek's AI model caused significant upheavals in the tech-led equity market, causing the NASDAQ to lose almost 4% within two days, although the loss has been partly recovered, and the general picture is still a positive one.

**Comments on positioning**

We keep global equities at attractive. While policy uncertainty is likely to inject volatility, we believe robust underlying fundamentals should prevail throughout the year. Our view on fixed income remains unchanged. We stay neutral overall and see investment-grade bonds as attractive. The trajectory of yields should continue to be a function of central bank rate cuts, but also how many of Trump's policy proposals are implemented by his administration and passed by Congress.

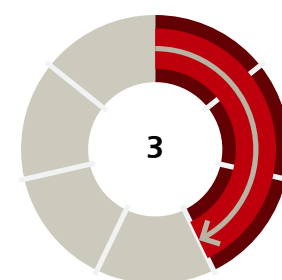

## Glossary

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO <sub>2</sub> -equivalent by million \$ sales. Intensities are broken down by GICS sector and are security weighted.
