

Performance commentary

After a lacklustre start to the year, equity markets rallied on the notion that Trump's trade war might not be waged against the whole world after all. Europe, and particularly Switzerland, outperformed, pricing in an increased likelihood of a ceasefire in Ukraine. Bond markets rallied in tandem with equities, with the US yield curve being the steepest since the beginning of 2022. The USD slowed its rally and remained relatively flat, while the GBP weakened further, thus boosting the FTSE 100's performance

Market comments

Since Donald Trump won the US presidential election and the Republicans gained control of Congress, long-end government bond yields have increased, the dollar has strengthened and equity markets have become more volatile. Tariffs are the area where the president has the most unilateral authority to alter the market consensus around continued growth and receding inflation. At least until the end of January, the world has been spared the most extreme measures, such as universal tariffs on all US imports, and markets reacted with a relief rally across asset classes. Central bank activity remained within expectations, with the Fed pausing rate cuts and the ECB cutting by 25bp. The release of Chinese start-up DeepSeek's AI model caused significant upheavals in the tech-led equity market, causing the NASDAQ to lose almost 4% within two days, although the loss has been partly recovered, and the general picture is still a positive one.

Comments on positioning

We keep global equities at attractive, while moving Europe from underweight to neutral. While policy uncertainty is likely to inject volatility, we believe robust underlying fundamentals should prevail throughout the year. Our view on fixed income remains unchanged. We stay neutral overall and see investment-grade bonds as attractive. The trajectory of yields should continue to be a function of central bank rate cuts and Trump's policy proposals. In the first half of 2025, broad dollar strength is likely to persist as relative growth and monetary policy dynamics speak for US assets.

Comments on transactions

We increased European equities to neutral, financed by other regions, which we rebalanced to take profit. Thus, the total equity portion remains unchanged.



Glossary

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
