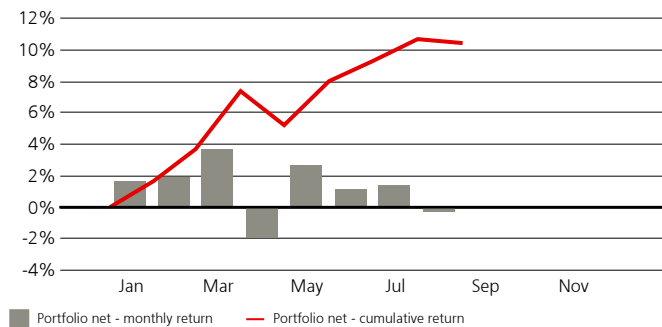
Investment Policy

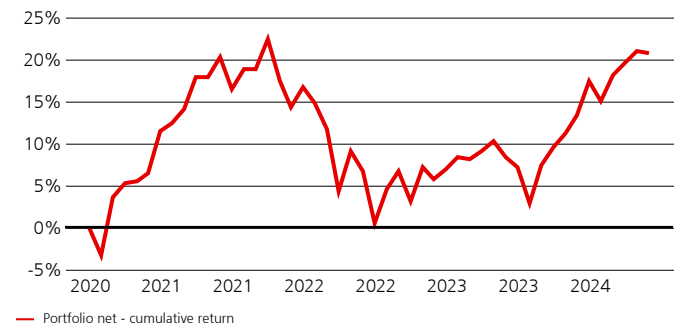
Performance overview - monthly & cumulative

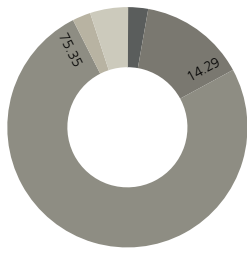

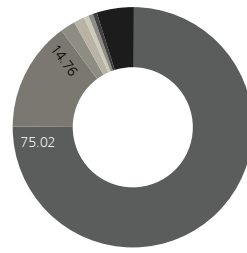
By asset class in % of total economic exposure

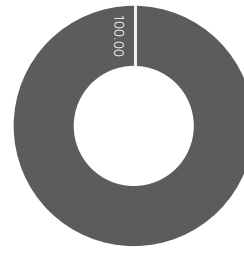
By instrument currency in % of total economic exposure (after currency hedging)

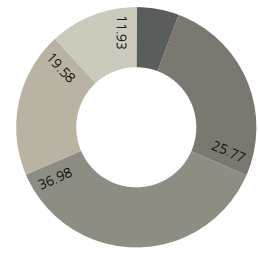
By type in % of bond economic exposure

Performance commentary

With the VIX index hitting its highest level since the pandemic after a disappointing July non-farm payrolls report, it was easy to feel like a US recession was due. Consequently, we saw a violent sell-off that lasted a few days, followed by an ongoing recovery. The S&P 500 erased its early-August losses, and the VIX fell back to around 15 – below its long-term average. Investors who stayed the course were rewarded.

Market comments

August saw both the largest one-day points fall in Japanese market history and the VIX volatility index spike to its highest level since the onset of the pandemic. This month has also seen a change in the polling around the US election, with Kamala Harris now leading by two percentage points. All of this raises questions about whether we are at the start of a bigger shift in the trajectory for markets, economies, politics and interest rates. Meanwhile, the case for a soft landing of the US economy remains intact if one focuses solely on the numbers. Unemployment rose to 4.3% in July, up from 3.7% just six months ago, while consumer price inflation slowed to 2.9% year over year in July, its lowest since early 2021, which should improve the Fed's confidence that inflation is on a sustainable path back to its 2.0% target. Towards the end of the month, we saw the first dent in the shiny façade of the AI growth story. Nvidia lost over 7% following the publication of its results, despite having surpassed consensus estimates.

Comments on positioning

While we see the overall environment as constructive for equities, uncertainty about the economic and political outlook is likely to persist. We close our most preferred stance on UK equities and remain neutral on equities overall. Our base case is for a soft landing for the US economy, with growth bottoming below the trend rate and inflation moderating further. Rates remain on an elevated level if viewed historically, and we believe there is still value in fixed income. We consequently keep investment grade on most preferred.

Comments on transactions

We reduced UK to its neutral quota and rebalanced select regions within the equity quota.

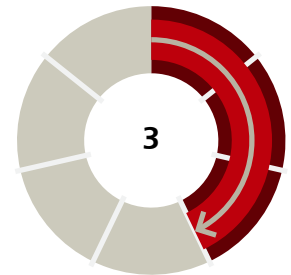

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO ₂ -equivalent by million \$ sales. Intensities are broken down by GICS sector and are security weighted.
