Investment Policy

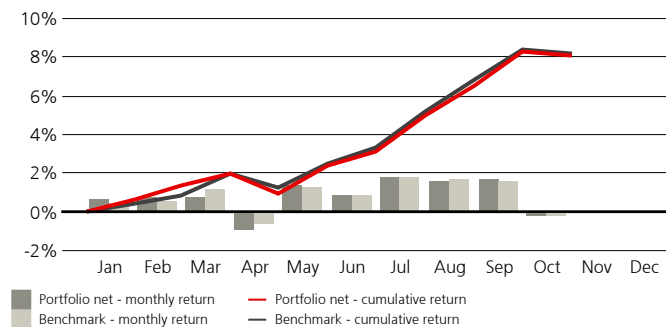

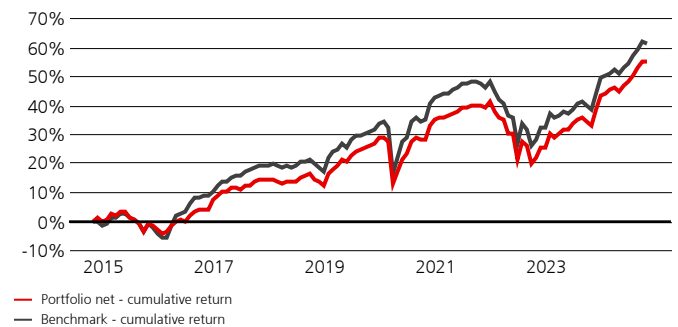
Performance overview - monthly & cumulative

Potential Risks

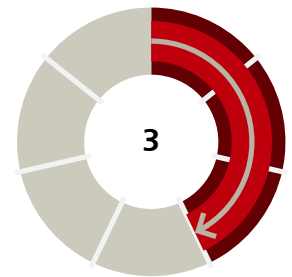
