Investment Policy

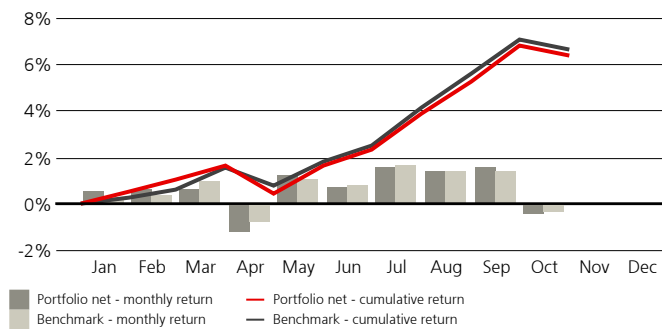

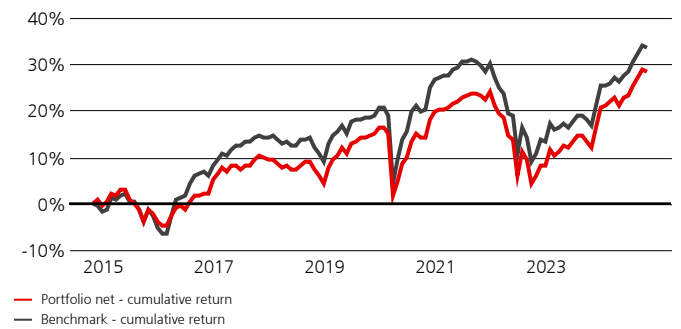
Performance overview - monthly & cumulative

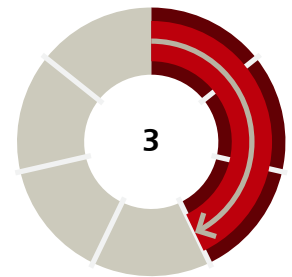
