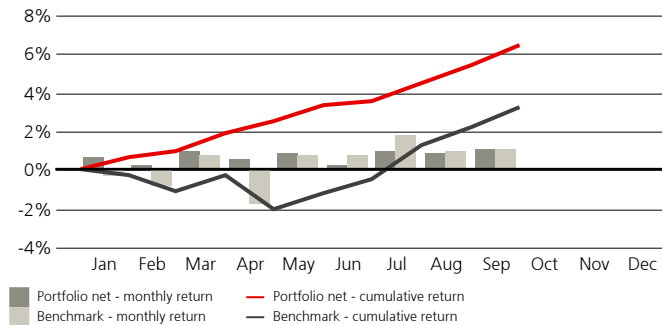
Investment Policy

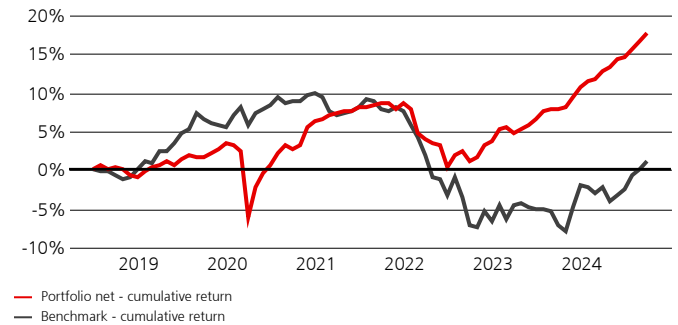
Performance overview - monthly & cumulative

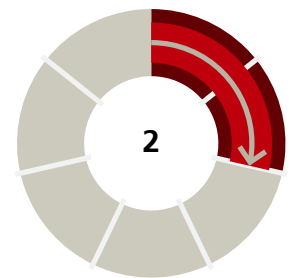

Performance review

The fund's current yield to maturity is 5.00% with a modified duration of 3.23 years and a spread duration of 2.62 years. The fund delivered a positive gross performance in September driven by carry, decreasing interest rate and falling credit spreads particularly in the US.

Market Review

Global fixed income markets ended Q3 with another month of positive returns in September amid a 50bp rate cut by the Fed and further pricing in of a "soft-landing" scenario. Macro data in the US were mixed, but generally reflected a cooling yet still resilient US economy. Another significant development took place in China, where the announcement of significant monetary and potentially fiscal stimulus measures sparked an impressive rally in Chinese risk assets, which also supported global risk sentiment. Yields on 5-year and 10-year US government bonds fell by 14bp and 12bp, respectively. Yields on the German 10-year Bunds followed suit and traded 18bp lower, while those on the UK 10-year Gilts were only 1bp lower. On the credit side, US investment grade credits outperformed their European counterparts. This was also the case for US and Euro high yield. Within emerging markets, both sovereigns and corporates generated positive returns with sovereigns leading the charge.

Asset breakdown by ESG controversy flag



Asset breakdown by ESG rating



Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Bottom-up	An investment approach that focuses on the analysis of individual stocks and de-emphasizes the macroeconomic environment.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO ₂ -equivalent by million \$ sales. Intensities are broken down by IBOXX sector and are security weighted.
