## Investment Policy

The fund aims to generate both income and capital growth, while seeking to preserve capital through adequate diversification. To achieve this objective the fund invests at least two-thirds of its assets in contingent capital securities and other hybrid, subordinated financial instruments issued by financial institutions. These securities are predominantly rated below investment grade. The main focus is on banks and insurance companies with solid capitalization, where the additional risk of this lower credit segment is expected to be compensated with higher returns. In order to manage risk and liquidity the fund maintains flexibility to invest across the capital structure (eg. adding senior bonds) and may use financial derivative instruments to hedge existing positions.

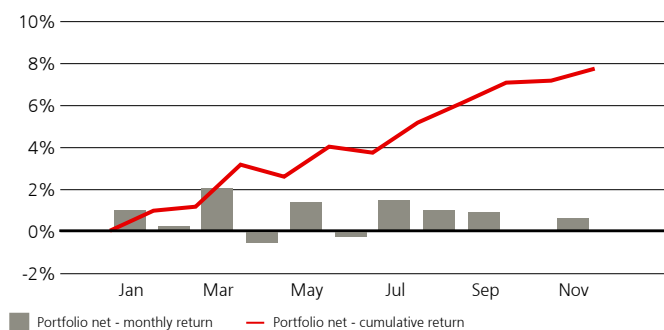
## Risks

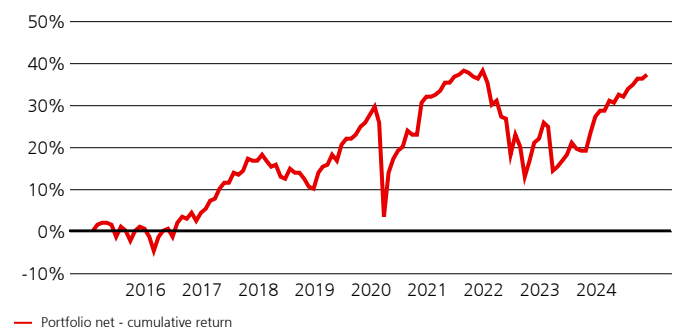
## Performance overview - monthly & cumulative

## Potential Risks

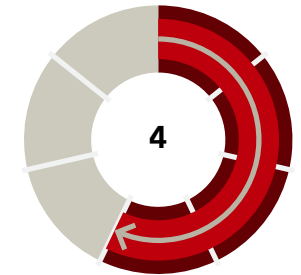

**Performance review**

The fund's current yield to maturity is 5.64% with a modified duration of 3.21 years and a spread duration of 4.75 years. The fund delivered a positive gross performance in November. Positive contributions came from all factors, mainly though from carry and falling interest rates. Credit selection contributed positively as well.

**Market Review**

Despite some volatility, global fixed income markets ended November higher. US Treasury yields initially rose as Trump's victory in the US election raised expectations regarding fiscal deficits and stickier inflation. That said, they subsequently fell back as the focus returned to the Fed's rate cut trajectory. The Fed cut rates by 25bp in November, with the FOMC minutes suggesting that more cuts will follow, albeit at a gradual pace. In Europe, weaker-than-expected inflation and PMI data weighed on the growth outlook, pushing government bond yields and the euro lower. While the headlines on potential tariffs proposed by Trump weighed on certain affected equity markets, credit spreads were largely stable globally, ending the month mostly flat or slightly wider. Yields on 5-year and 10-year US Treasuries were down by 11bp and 12bp respectively. Yields on German 10-year Bunds and UK 10-year bonds traded 30bp and 20bp lower, respectively, amid weaker data. On the credit side, all markets posted positive returns. Within developed markets, European High Yield lagged its US counterpart due to some spread widening. Within emerging markets, corporates lagged sovereigns for the same reason.

**Potential capital loss:** If the capital ratio of an issuing bank drops below a predetermined trigger, the CoCo bond will automatically be converted into equity or its nominal value will be written down in full or in part. In the event of a conversion to equity, investors may have to purchase the shares at a much lower price than when the CoCo bond was purchased.
