

Investment Policy


The Fund invests primarily in US Dollar denominated bonds of corporate, quasi-sovereign & semi-government issuers which are domiciled in or carry out the bulk of their business activities in the Latin American region. The Investment Universe contains Investment Grade as well as High Yield issuers and is broadly diversified across countries, sectors and ratings. The fund aims to deliver superior returns compared to Benchmark over the entire economic cycle. The fund is actively managed based on an investment process considering top-down and bottom-up elements. This share class provides a hedge against currency risk versus the reference currency (USD).



Performance review

The Latin America Corporate Bond Fund outperformed the market in September and, as of the end of September in the year to date, is slightly ahead of the overall market. From a country perspective, the fund saw a positive performance contribution from Argentina through security selection and the overweight. Moreover, in Colombia, the fund generated a positive performance contribution through security selection. Within sectors, positive contributions through security selection are from the oil & gas and the industrial segment. The overweight in the high yield segment had a positive impact on the fund's performance compared to the overall market.

Market Review

In September, Latin America Corporates generated very positive returns. Both drivers – yields from US Treasuries and credit spreads ended the month at lower levels. The 2-year Treasury yield ended at 3.642% (-0.277%), the 10-year Treasury yield ended at 3.782% (-0.122%) and the 30-year Treasury yield ended at 4.12% (-0.076%). With this move, the yield curve steepened further. Credit Spreads tightened with -3bp to 293bp. Countries such as Jamaica, Trinidad and Tobago, Costa Rica and Paraguay, which are represented with smaller weights in the index, generated the highest returns. Argentina, Brazil and Peru outperformed the index. Mexico, while still generating positive returns, underperformed the index. In terms of sectors, all sectors generated a positive return with best-performing sectors transport and industrial. In general, the high yield segment outperformed the investment-grade segment. On the primary market, as expected after the summer break, many issuers were active and issued bonds.

Clossary	
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Bottom-up	An investment approach that focuses on the analysis of individual stocks and de-emphasizes the macroeconomic environment.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO2-equivalent by million \$ sales. Intensities are broken down by JPM CEMBI sector and are security weighted.
Distributing	Payment of an investment fund to distribute the income generated to its unit holders.
ESG aware	This product undertakes investments that explicitly assess and integrate the sustainability characteristics of companies in the investment process.
ESG benchmark	A ticked 'ESG benchmark' box reflects that the ESG section in this document compares the ESG performance of the portfolio with an ESG index.
