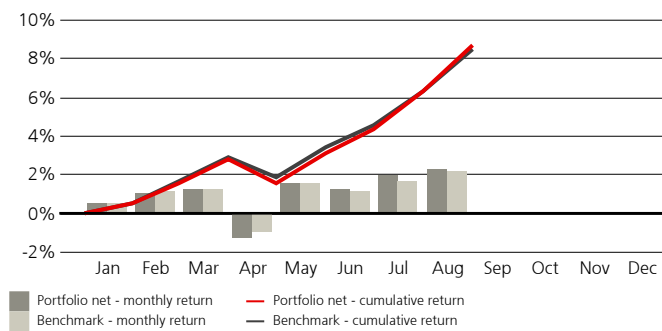
Investment Policy

The Fund invests primarily in US Dollar denominated bonds of corporate, quasi-sovereign & semi-government issuers which are domiciled in or carry out the bulk of their business activities in the Latin American region. The Investment Universe contains Investment Grade as well as High Yield issuers and is broadly diversified across countries, sectors and ratings. The fund aims to deliver superior returns compared to Benchmark over the entire economic cycle. The fund is actively managed based on an investment process considering top-down and bottom-up elements. This share class provides a hedge against currency risk versus the reference currency (USD).

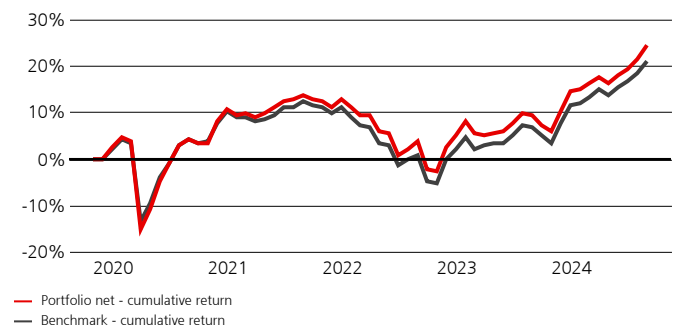
Performance overview - monthly & cumulative

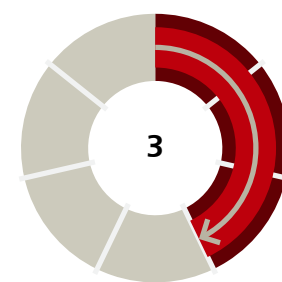

Performance review

The Latin America Corporate Bond Fund outperformed the market in August and, as of the end of August in the year to date, is slightly ahead of the overall market. From a country perspective, the fund saw a positive performance contribution from Argentina through security selection and the overweight. Moreover, in Colombia, the fund generated a positive contribution to performance through security selection. Within sectors, positive contributions through security selection are from the oil & gas and the industrial segment. The overweight in the high yield segment had a positive impact on the fund's performance compared to the overall market.

Market Review

In August, the performance of Latin American corporate bonds was very positive with both positive contribution from both tighter credit spreads and lower US Treasury yields. US 2-year Treasury yields tightened by 34 basis points (bp) to 3.92%, while yields on 10-year and 30-year Treasury bonds decreased by 13bp to 3.9% and 11bp to 4.2%, respectively. The US Treasury curve remains slightly inverted with the yield differential between 2- and 10-year US Treasury notes ending the month at -2bp. Not surprisingly, higher beta markets such as Argentina or Colombia outperformed the overall market. In terms of sectors, oil & gas and metals & mining outperformed – which is also typical. The high yield market outperformed the investment grade market.

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Bottom-up	An investment approach that focuses on the analysis of individual stocks and de-emphasizes the macroeconomic environment.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO ₂ -equivalent by million \$ sales. Intensities are broken down by JPM CEMBI sector and are security weighted.
