#### **Investment Policy**

The Fund invests primarily in US Dollar denominated bonds of corporate, quasi-sovereign & semi-government issuers which are domiciled in or carry out the bulk of their business activities in the Latin American region. The Investment Universe contains Investment Grade as well as High Yield issuers and is broadly diversified across countries, sectors and ratings. The fund aims to deliver superior returns compared to Benchmark over the entire economic cycle. The fund is actively managed based on an investment process considering top-down and bottom-up elements. This share class provides a hedge against currency risk versus the reference currency (USD).



#### **Performance review**

The fund outperformed the market. In a country comparison, the fund outperformed in Argentina and Brazil on the back of security selection and the overweight positioning. From a sector point of view, the fund strategy gained on a relative comparison in the oil & gas, metals & mining, financials and pulp & paper segments on the back of security selection. In general, the overweight in the high yield segment helped the fund strategy. In November, the fund participated selectively in new issues. Going into December, typically liquidity will be reduced from the second half of the month onwards.

#### **Market Review**

In November, Latin America corporates generated positive returns. Risk-free Treasuries have decreased while credit spreads have widened. The 2-year US Treasury yields have decreased by 2 basis points (bp) to 4.15%, while the 10-year yields decreased by 12bp to 4.17% and the 30-year yields by 11bp to 4.36%. Credit spreads have widened by 10bp to 292bp. On the back of the carry effect, the high-yield segment has slightly outperformed. From a country point of view, most companies in Latin America countries generated positive returns. Corporates from Argentina and Colombia were the top performers. From a sector point of view, the oil & gas and transport segments generated the highest returns, whereas the real estate and financials sectors were among the underperformers. In general, lower-rated companies on the rating ladder outperformed higher-quality names.

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are

Annualized return	A measure of how much an investment has increased on average each year during a specific period.
