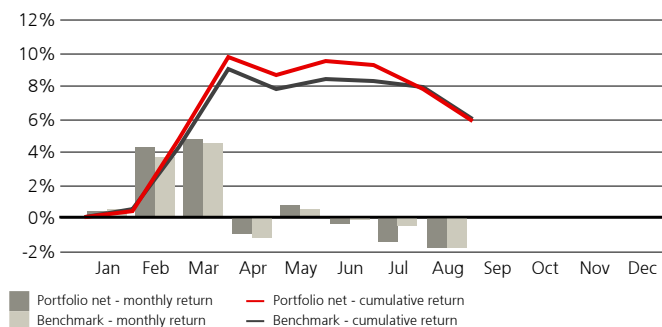

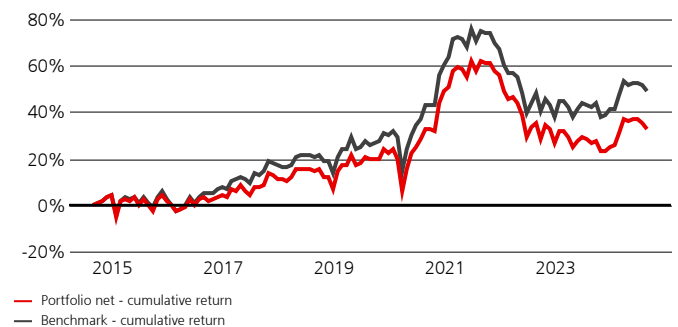
Performance overview - monthly & cumulative

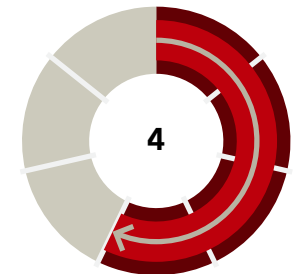

Performance review

In an overall very positive month for global convertible bonds, the fund could not quite keep up with its benchmark index. Our top contributor was an overweight (O/W) in Exact Sciences. The stock of the US Biotech company spiked early in the month on the back of a Q2 earnings beat. Our O/W in the convertible added 9 basis points (bp) in relative performance. Our underweight (U/W) in Super Micro Computer generated another 7bp. The AI-hyped stock tanked after delaying their annual report only one day after short seller Hindenburg came out with a negative report. Furthermore, our new issue participation in the new deal of ANI Pharmaceuticals added 5bp. At the other end of the spectrum, our off-Benchmark position in Pacira Biosciences cost 11bp as the stock of the US Biotech company plunged mid-month after a US court found the Exparel patent (one of its key franchises) invalid. In addition, our O/W in MicroStrategy, best-known for its large-scale bitcoin purchases, detracted 8bp in relative performance, amid a pullback in the cryptocurrency. Lastly, our O/W in Wolfspeed cost another 7bp. The US chip manufacturer continued its negative trajectory in August. We reduced our position to neutral. On the new issue front, we were very active in May and participated in the deals of LEG Immobilien and ANI Pharmaceuticals.

Market Review

August proved a rather constructive month for risky assets. Global convertible bonds (USD-hedged) gained 1.38% during the month (+5.63% YTD), recording their fourth consecutive month of positive returns in 2024. Global equities (USD-hedged) delivered a somewhat better +1.91% return, closing at a new monthly high. Rates continued their relentless march lower as the September Federal Reserve meeting drew near and with it the likely timing of the first reduction in the Fed funds target rate since March 2020. The yield on the 10-year Treasuries had a monthly close below the psychological 4.0% level for the first time since January, while European sovereign yields were little changed in spite of the European Central Bank already having lowered rates by 0.25% back in June. The Bank of Japan finally delivered its first rate hike above the zero bound in two decades, briefly sending Japanese equities into a tailspin. The flagship Nikkei-225 stock index plunged by more than 12% on Monday, 5 August but recovered fairly quickly to end the month with a much more palatable 1.16% decline, while the yield on 10-year Japanese government bonds ("JGBs") actually declined by more than 16 basis points ("bp") ending August at just 0.89%. Credit spreads, as measured by the ITRX Xover EUR, followed the risk-off move of other asset classes in the first half of August. However, the Index for High Yield European Credit Spread more than reversed that move and ended the month on new YTD low. Meanwhile, the US dollar depreciated substantially against the major currencies in August (DXY: -2.3%), helping Gold to reach a fresh all-time high of over USD 2,500/oz.

Glossary

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Bond floor	Denotes how far the portfolio is from the lowest value that convertible bonds can fall to, which is calculated by adding the discounted present value of the coupons and the redemption value.
Bottom-up	An investment approach that focuses on the analysis of individual stocks and de-emphasizes the macroeconomic environment.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO ₂ -equivalent by million \$ sales. Intensities are broken down by GICS sector underlying and are security weighted.
Delta	A ratio comparing the change in the price of an asset, usually a marketable security, to the corresponding change in the price of its derivative.
Distributing	Payment of an investment fund to distribute the income generated to its unit holders.
ESG aware	This product undertakes investments that explicitly assess and integrate the sustainability characteristics of companies in the investment process.
ESG benchmark	A ticked 'ESG benchmark' box reflects that the ESG section in this document compares the ESG performance of the portfolio with an ESG index.
