

Investment Policy

UBS (CH) Property Fund - Direct LogisticsPlus is the first Swiss real estate fund to invest primarily in logistics buildings and logistics-related real estate in Switzerland. The fund focuses in particular on logistics and goods distribution centers (warehouses, handling facilities, high-bay warehouses) along with industrial buildings used for production and processing (light industrial) and data centers. The fund can also invest in vehicle dealerships (for cars, trucks, etc.), replacement parts warehouses, filling stations, parking garages, etc. Further possible investments include commercial properties and multifunctional buildings that are used for production, distribution, and logistics purposes, and may also be used for other business purposes. The fund has been listed on the SIX Swiss Exchange since 2020. It gives institutional and private investors access to a logistics portfolio. The fund takes direct ownership of the properties, which means that unit holders are not subject to Swiss income or wealth tax on the portion of the fund's assets that is invested in real estate.
