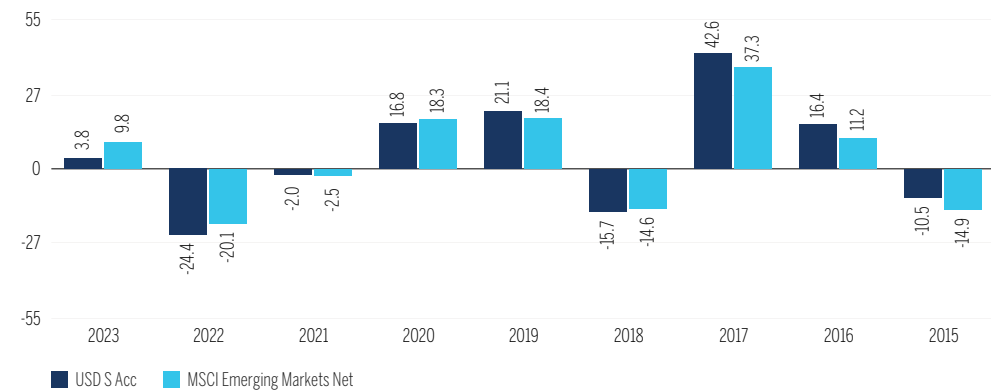

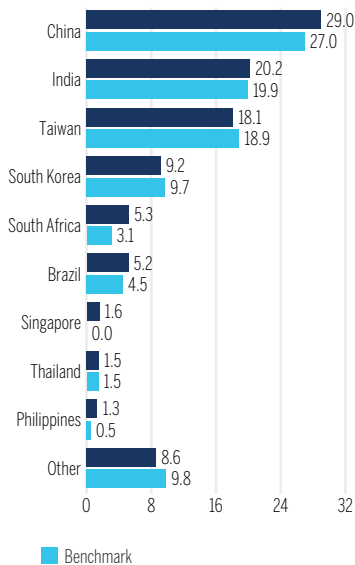

GEOGRAPHIC BREAKDOWN

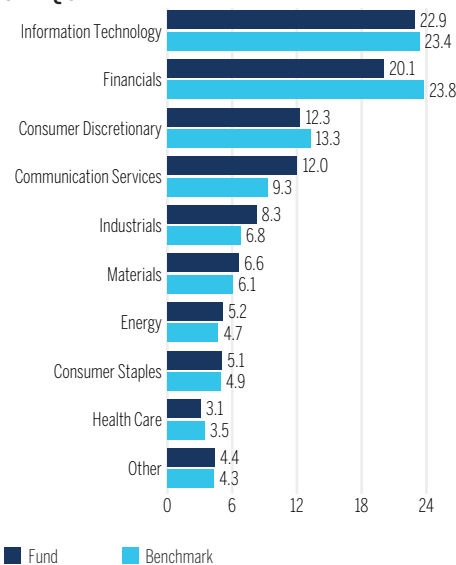
% OF EQUITY
