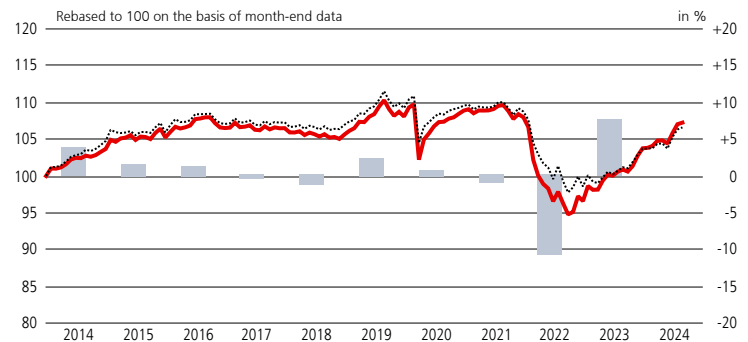

- The fund may also invest opportunistically in non-denominated CHF bonds, emerging market and high yield bonds. The portfolio has an average credit quality of investment grade.
