- The exchange rate risk between CNY and USD is largely hedged. The portfolio manager is not tied to the benchmark in terms of investment selection or weight.

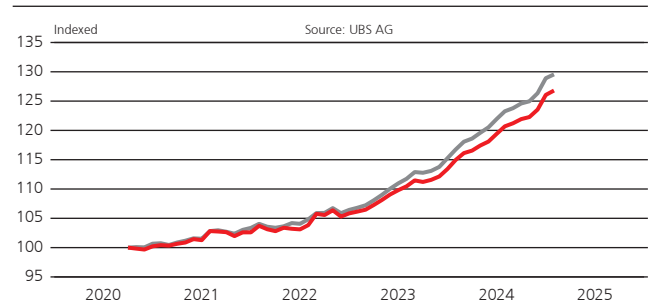
