- The portfolio manager is not tied to the benchmark in terms of investment selection or weight.







**Aggregation of ESG/carbon data**: ESG scores of holdings in the portfolio and the reference index are aggregated based on their respective individual weights and ESG scores (sumproduct).

Derivatives and fund of funds investments used in the portfolio are treated on a lookthrough basis, whereby the economic exposures to the underlying basket of securities is treated as an actual investment in the individual securities that make up this basket. Weighted average carbon intensity – corporate issuers/ carbon-intensive sovereign issuers:These metrics measure a fund's exposure to carbon-intensive companies and governments.
