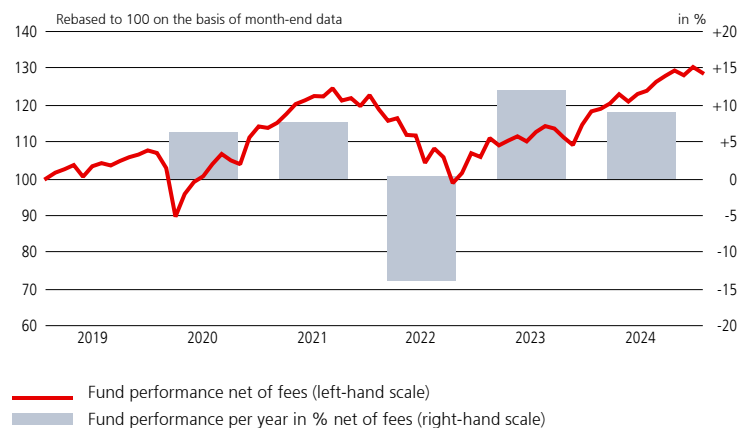

The effective weights therefore are very close to the target weights. A breakout of the third party flexible multi-sector bond fund holdings are not included in the bond figures as UBS has no timely and precise look-through into their holdings. Third party flexible multi-sector bond funds are therefore represented by a separate line item in the above table.

## Benefits

Multi-asset income strategy that harvests income from a global diversified range of asset classes. Compared to single asset classes, a diversified multi asset portfolio can provide more stable income and an improved risk-adjusted performance. A dynamically-managed, UBS GWM CIO aligned asset allocation can better navigate risk and opportunities throughout the course of a market cycle.

## Additional information

- Foreign currencies are largely hedged versus the reference currency. Nevertheless, an active currency strategy is applied if opportunities are seen.
- The fund invests without any benchmark restrictions. The performance of the fund is not benchmarked against an index.
- The exchange rate risk between USD and HKD is not hedged.

## Risks

The fund invests in equities as well as bonds with lower credit ratings or longer duration and can undergo major value fluctuations. The fund may hold substantial assets in fixed income with higher issuer default or liquidity risk. Its value will also be impacted by interest rate and credit spread movements. Due to the sale of call options, the fund can lag behind general growth levels during bull market phases. Despite the dynamic asset allocation adapting to various market cycle stages, the fund may nevertheless fail to meet its target income range.
