The Portfolio Manager rebalances the portfolio back to the target weights each month end (leaving a flexibility of up to +/-1% deviation from target). The effective weights therefore are very close to the target weights. A breakout of the third party flexible multi-sector bond fund holdings are not included in the bond figures as UBS has no timely and precise look-through into their holdings. Third party flexible multi-sector bond funds are therefore represented by a separate line item in the above table.

#### **Benefits**

A dynamically-managed, UBS GWM CIO aligned asset allocation can better navigate risk and opportunities throughout the course of a market cycle.

#### Risks
