### Portrait

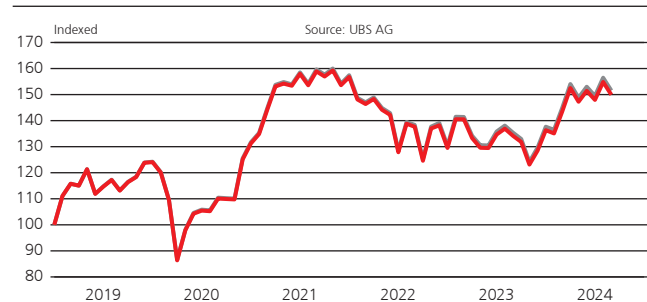
