Portrait

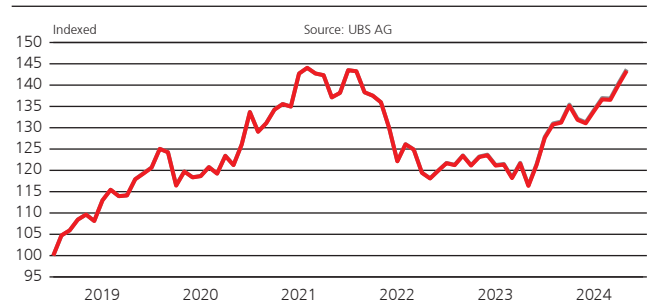
