Tracking Error: A measure of the volatility of the difference between the return to an investment strategy and the return to its benchmark. Vehicle: Any structure established to accept cash from investors with which to make investments in assets and securities. Examples include closed- or open-ended collective investment funds, limited partnerships, and exchange traded funds.

Volatility: Also referred to as the standard deviation of the stream of returns to an asset, portfolio, market or benchmark.
