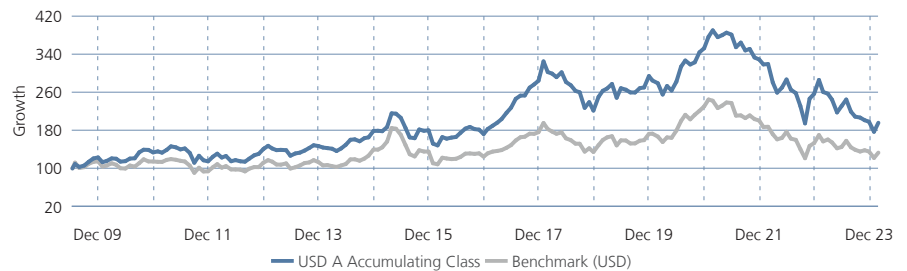

RISK CONSIDERATIONS
