FUND OBJECTIVE

The fund aims to achieve a target average return of 1-2% over the benchmark before fees over a market cycle (typically 3 years) and to have a positive social and environmental impact by investing primarily in corporate debt issued in emerging (less developed) market countries that comply with the Sustainable Exclusion Policy, as detailed in the "Sustainable Investment Criteria" section in the prospectus. There can be no guarantee that the fund will ultimately achieve its investment objective and capital invested is at risk. Investments will primarily be in hard currency but up to one third of the portfolio may be denominated in local currencies. 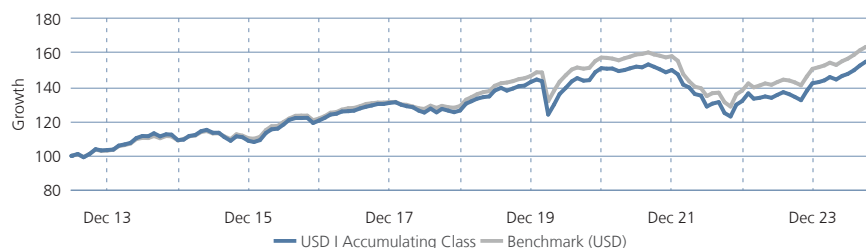

RISK CONSIDERATIONS
