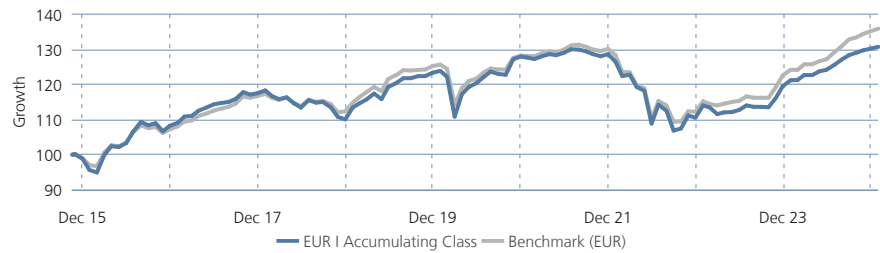

RISK CONSIDERATIONS
