

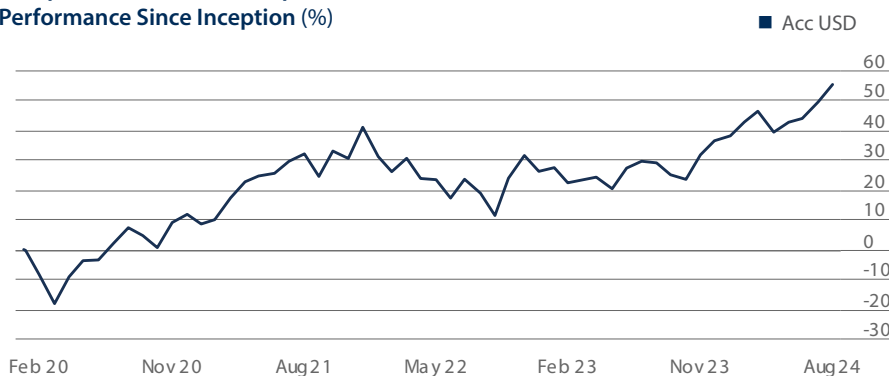
First Trust Capital Strength UCITS ETF

The Fund is a passively managed index-tracking fund that seeks investment results that correspond generally to the price and yield (before the Fund's fees and expenses) of an equity index called The Capital Strength IndexSM (the "Index"). In order to achieve its investment objective, the investment policy of this Fund is to invest at least 90% of its net assets in the common stocks and real estate investment trusts that comprise the Index or in depositary receipts that may include American Depositary Receipts, Global Depositary Receipts, European Depositary Receipts representing securities in the Index where direct investment in a constituent security of the Index is not possible.

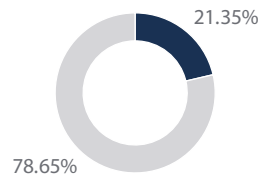

- From the stocks in the NASDAQ US Benchmark Index, the largest 500 companies with a minimum three-month average daily dollar trading volume of \$5 million are selected.
- To be eligible for inclusion in the Index, companies must have: i. at least \$1 billion in cash or short term investments; ii. a long term debt to market cap ratio less than 30%; iii. a return on equity greater than 15%.
- Eligible companies are then ranked by a combined short-term (3-month) and long-term (1-year) realized volatility.
- The 50 companies with the lowest combined volatility score are selected for inclusion in the Index.
- A maximum weight of 30% in any one Industry Classification Benchmark industry is allowed. If an industry has a weight greater than 30%, the highest ranking security by volatility will be removed and replaced with the next eligible security from a different industry. This process is repeated until no industry has a weight greater than 30%.
- The Index stocks are equally weighted initially and on each rebalancing effective date. The Index is reconstituted and rebalanced on a quarterly basis.
