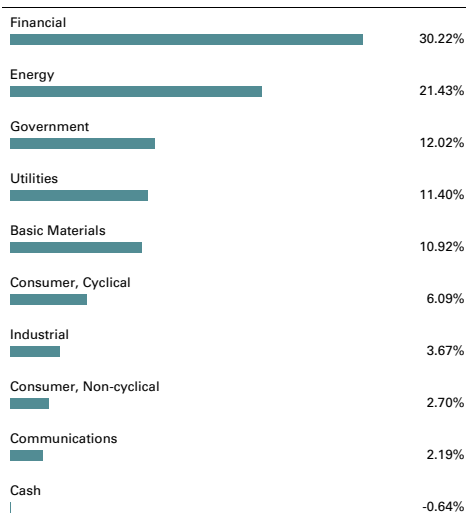

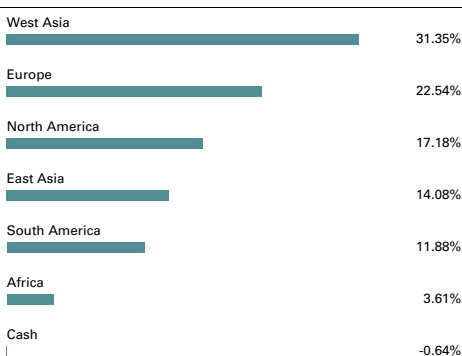

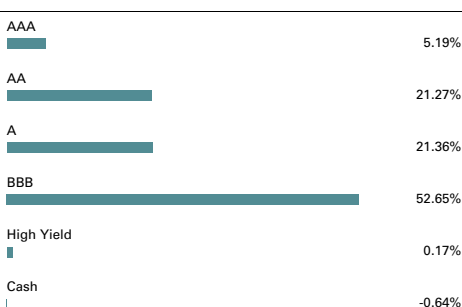

Regional Allocation



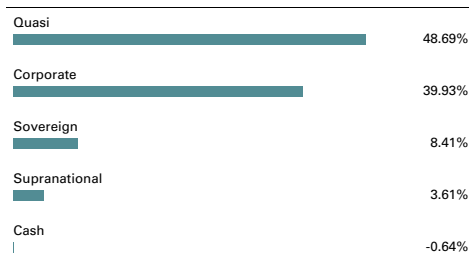

Credit Allocation



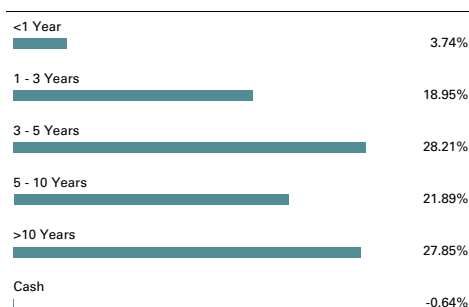
