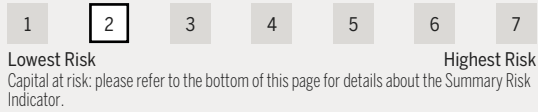

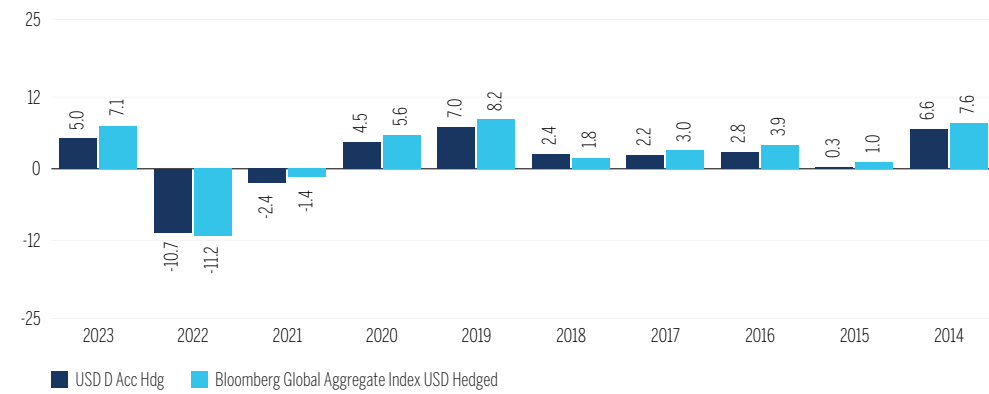

WHAT ARE THE RISKS?

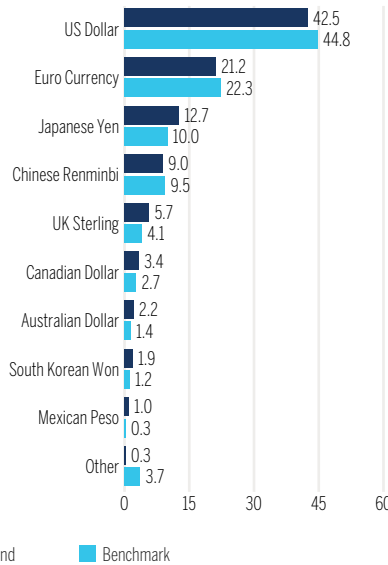

CURRENCY EXPOSURE

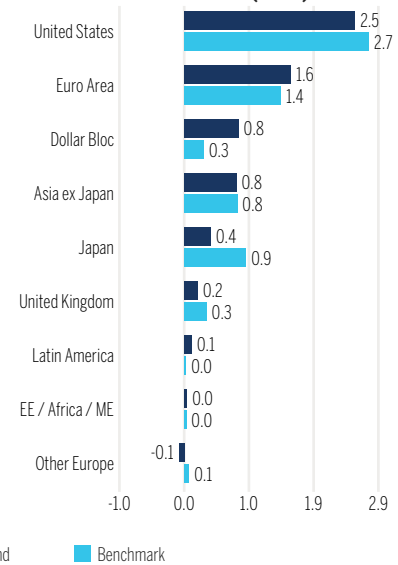
% CURRENCY EXPOSURE

GEOGRAPHIC DISTRIBUTION

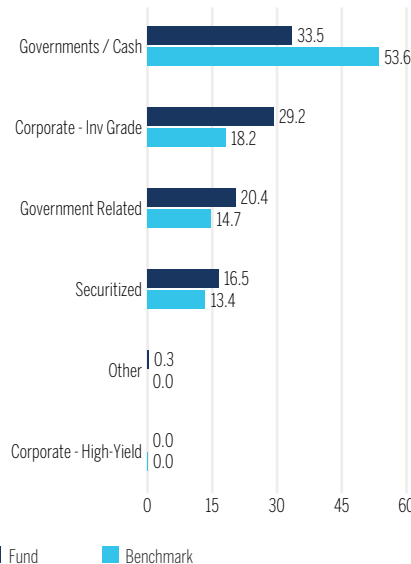
CONTRIBUTION TO DURATION (YRS)

SECTOR DISTRIBUTION

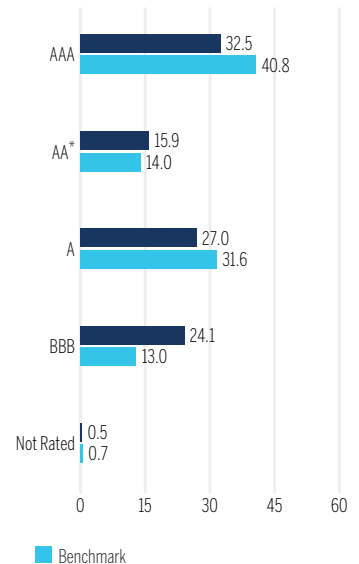
% MARKET VALUE
