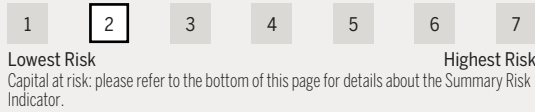

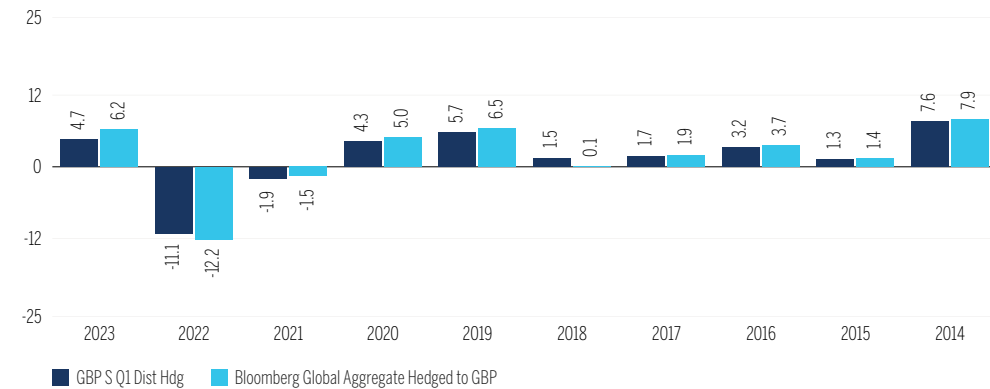

**WHAT ARE THE RISKS?**

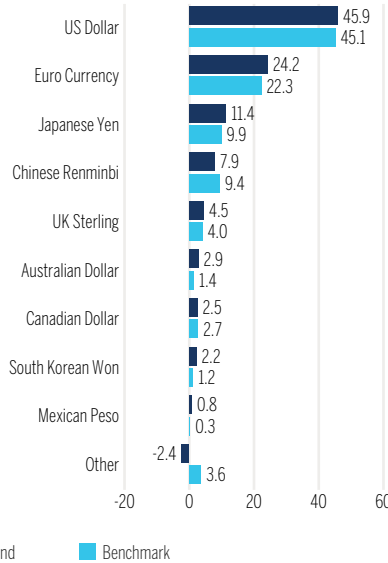

**CURRENCY EXPOSURE**

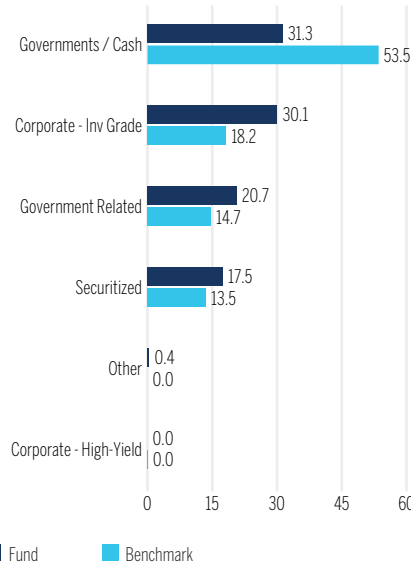
**% CURRENCY EXPOSURE**

**SECTOR DISTRIBUTION**

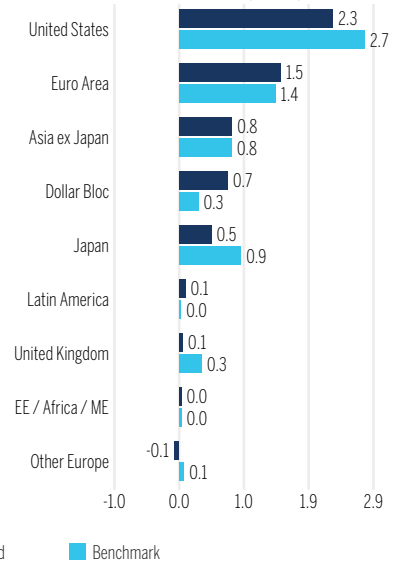
**% MARKET VALUE**

**GEOGRAPHIC DISTRIBUTION**

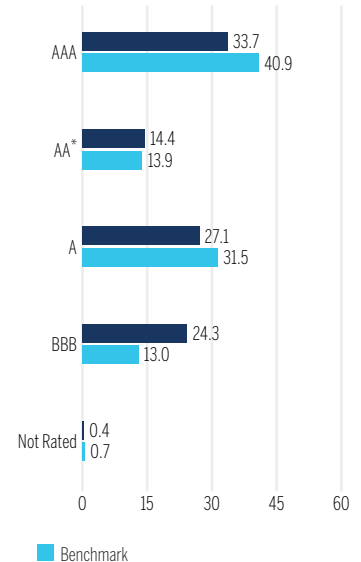
**CONTRIBUTION TO DURATION (YRS)**
