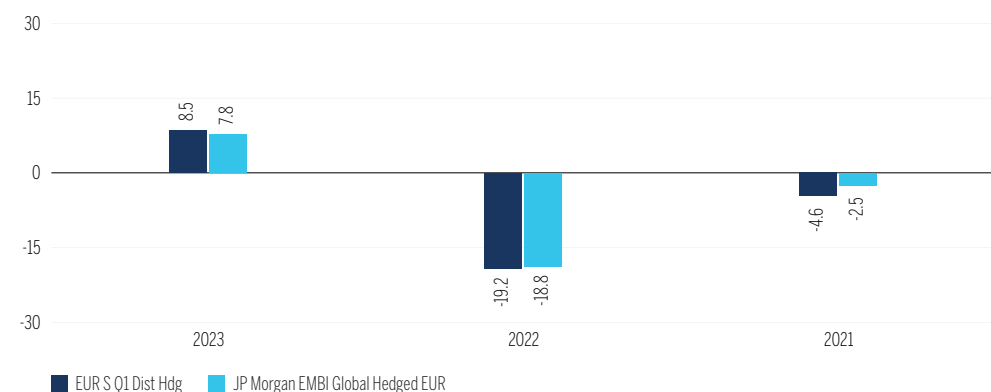

WHAT ARE THE RISKS?

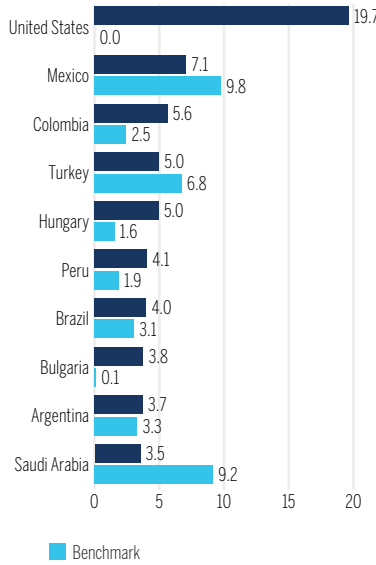

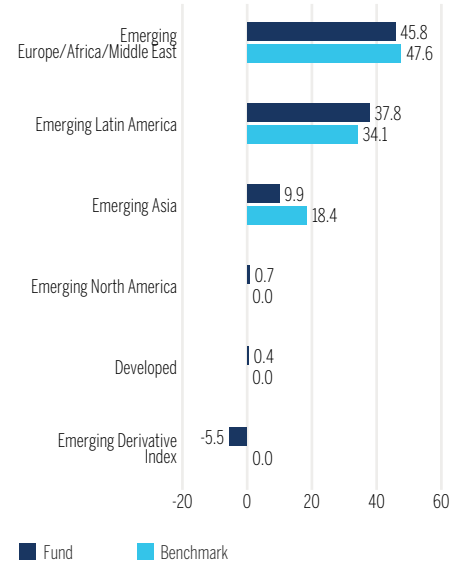
TOP 10 MARKETS

REGIONAL DISTRIBUTION

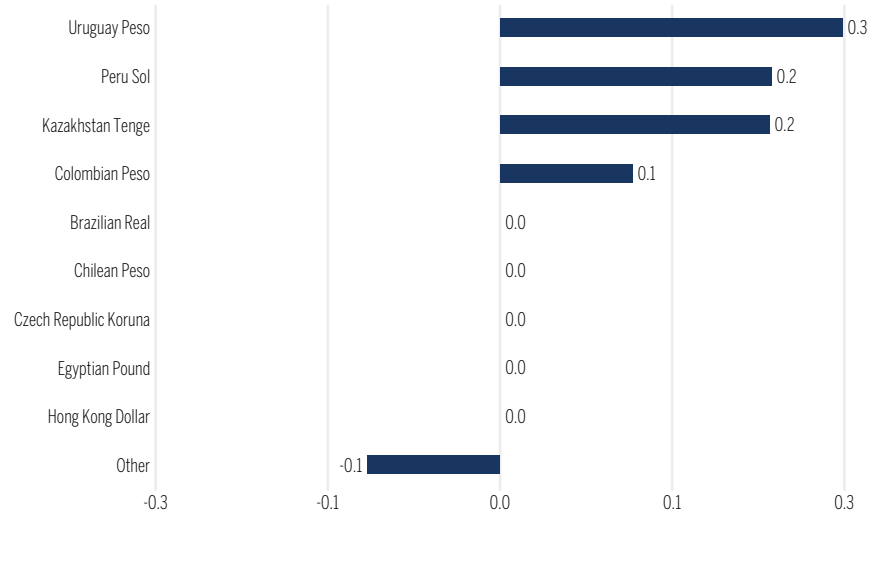
% MARKET VALUE
