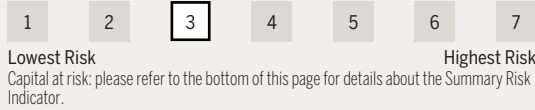

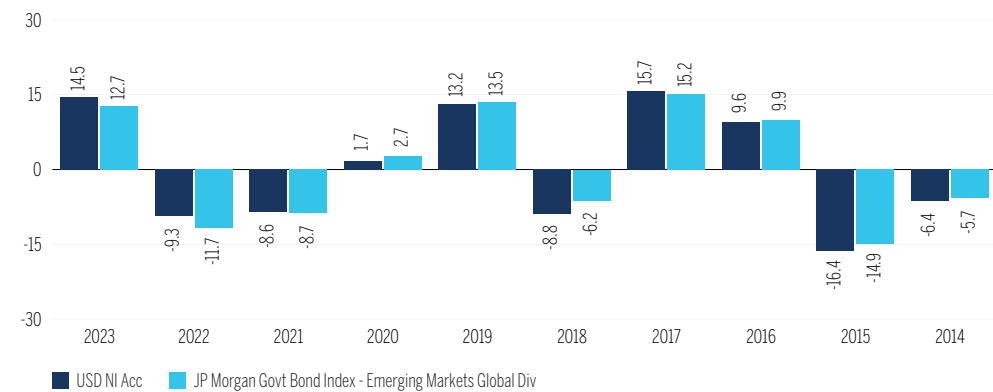

**WHAT ARE THE RISKS?**

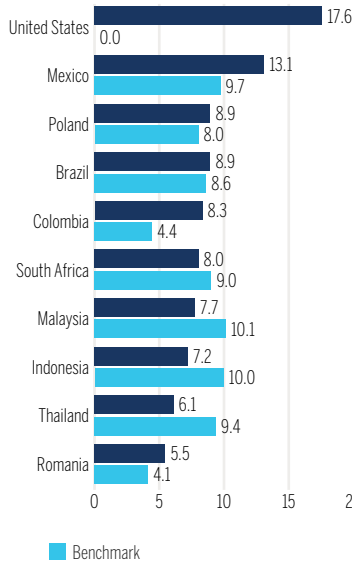

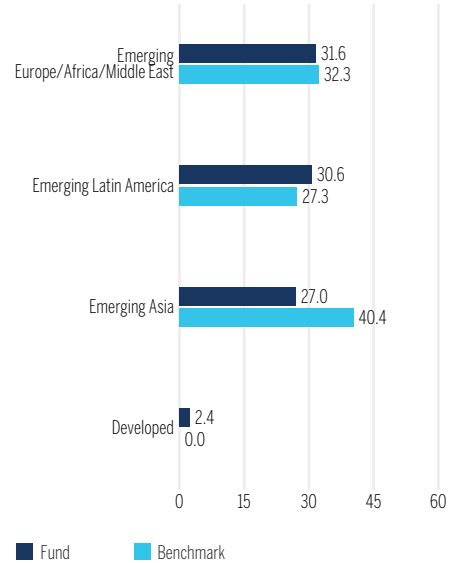
**TOP 10 MARKETS**

**REGIONAL DISTRIBUTION**

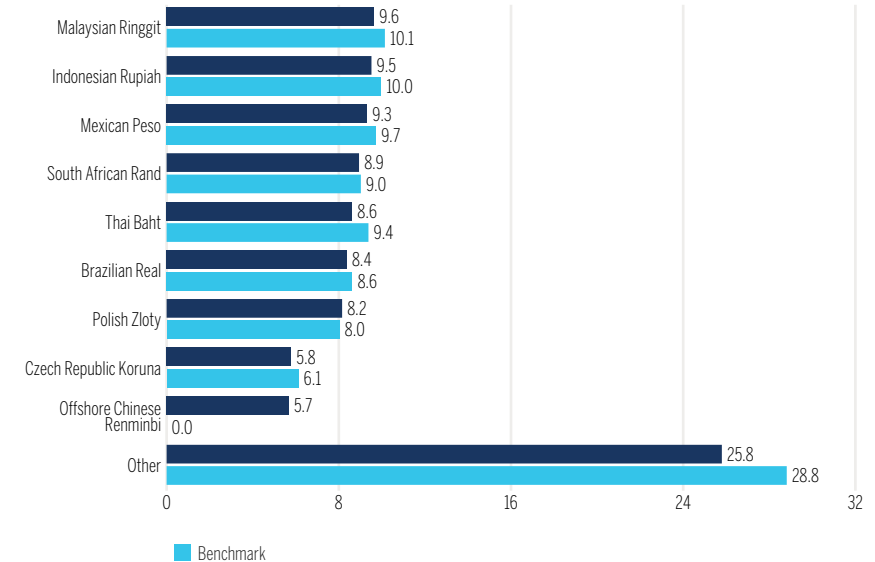
**% MARKET VALUE**
