The Investment Manager will actively manage the Fund, seeking to achieve the objective by investing primarily in a diversified portfolio of investment grade corporate debt instruments, including exchange-traded and over-the-counter derivatives.

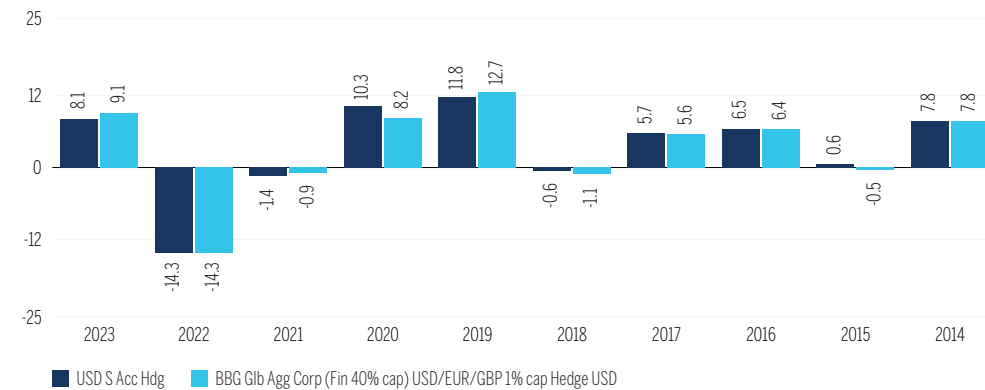

**WHAT ARE THE RISKS?**

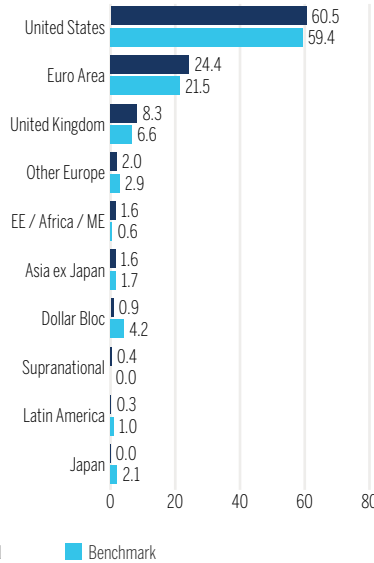

**GEOGRAPHIC DISTRIBUTION**

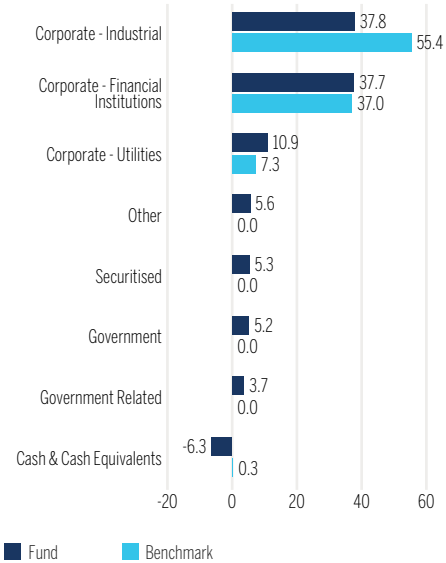
**% MARKET VALUE**

**SECTOR DISTRIBUTION**

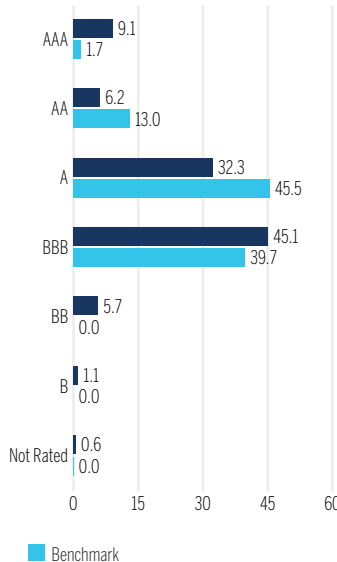
**% MARKET VALUE**

**QUALITY DISTRIBUTION**

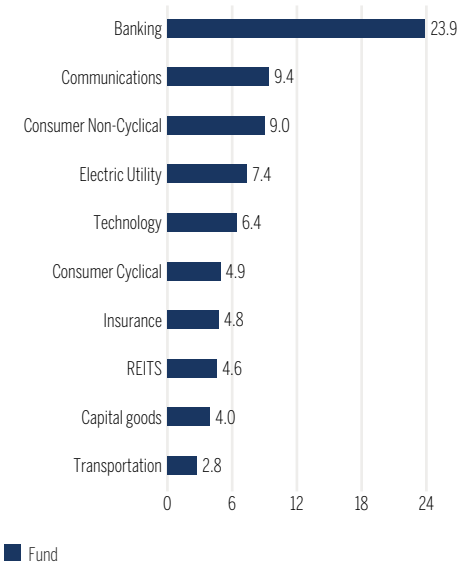
**% MARKET VALUE EX CASH**
