



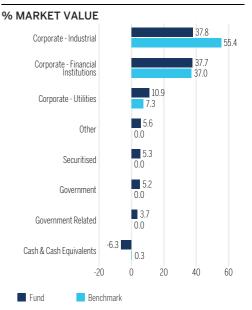

GEOGRAPHIC DISTRIBUTION








