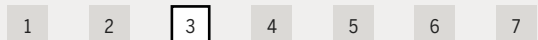

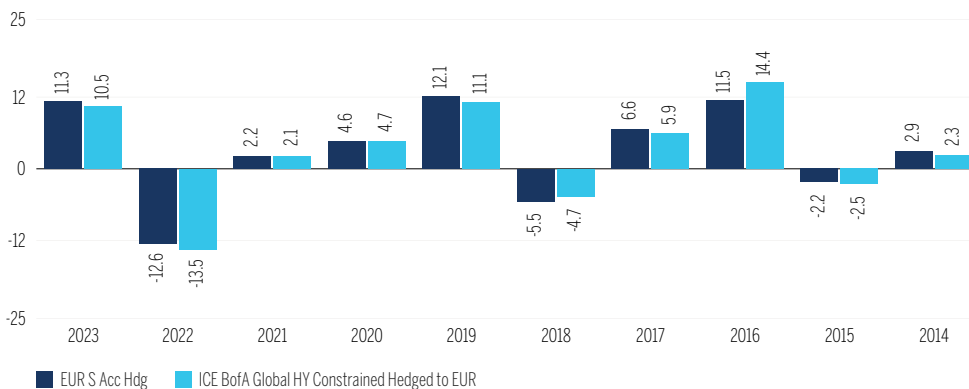

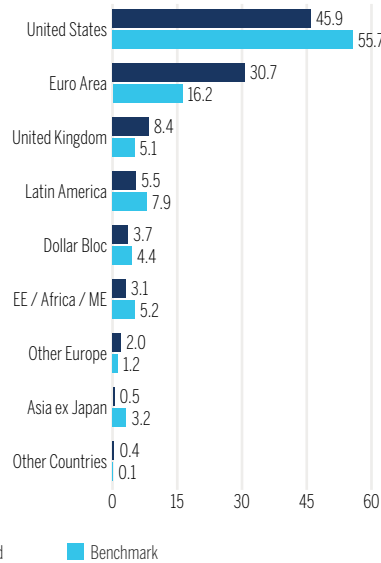

**GEOGRAPHIC DISTRIBUTION**

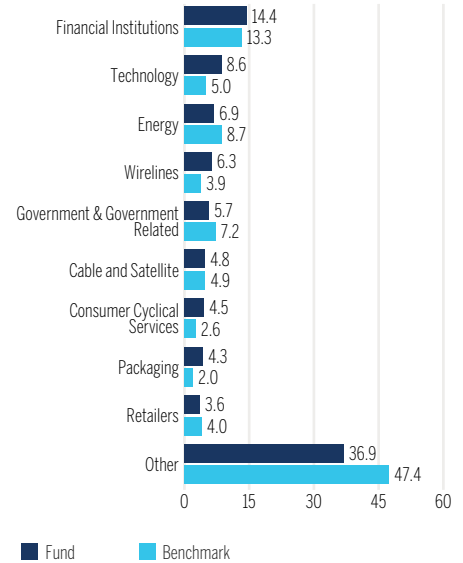
**% MARKET VALUE**

**SECTOR DISTRIBUTION**

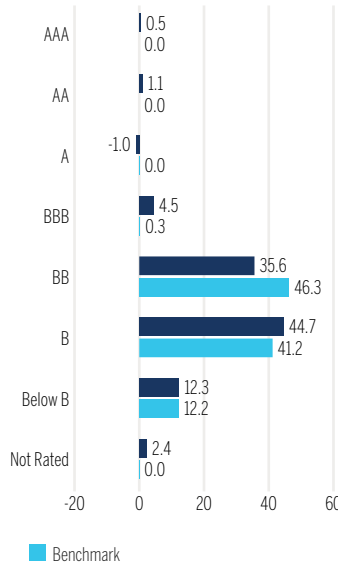
**% MARKET VALUE**

**QUALITY DISTRIBUTION**

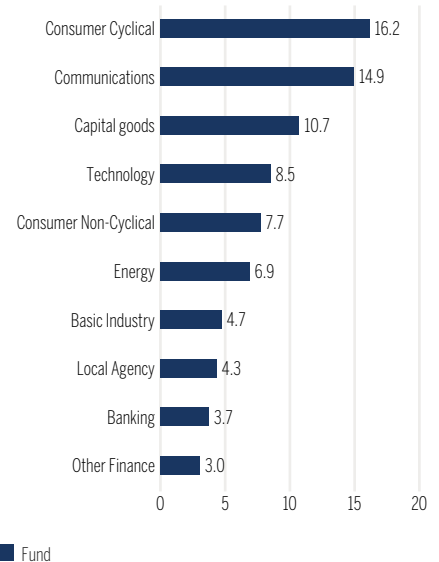
**% MARKET VALUE EX CASH**
