





#### % MARKET VALUE





# QUALITY DISTRIBUTION % MARKET VALUE EX CASH



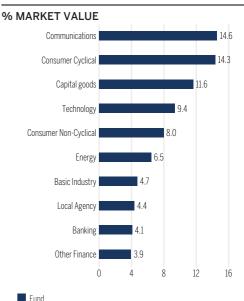
