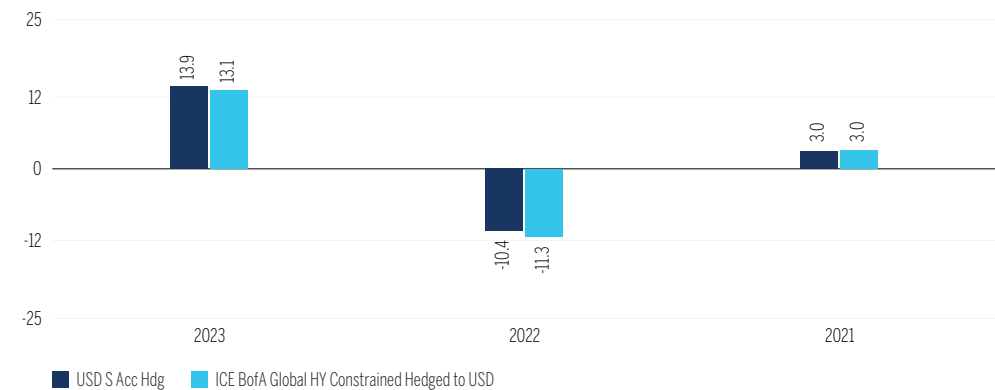

**WHAT ARE THE RISKS?**

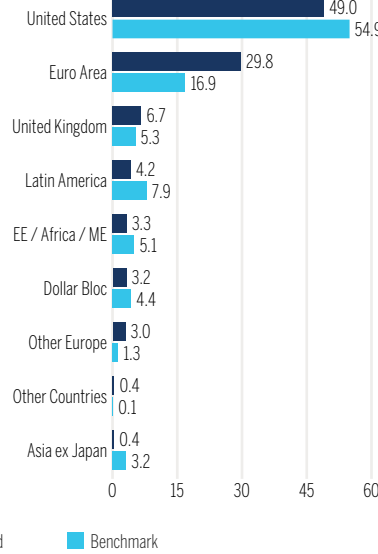

**GEOGRAPHIC DISTRIBUTION**

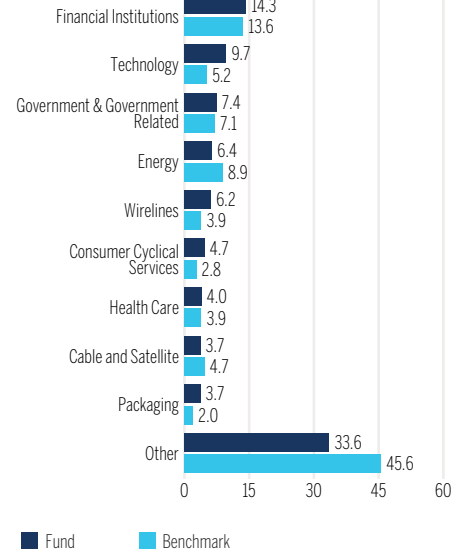
**% MARKET VALUE**

**SECTOR DISTRIBUTION**

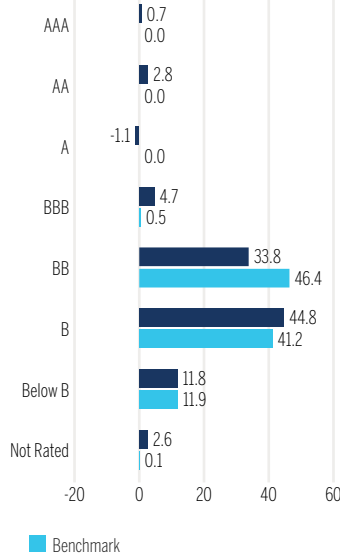

**QUALITY DISTRIBUTION**

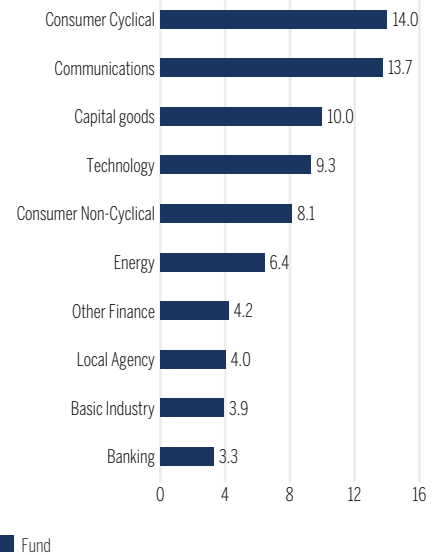
**% MARKET VALUE EX CASH**
