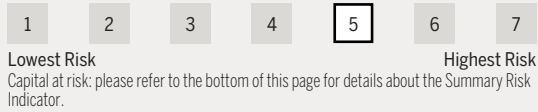

Using fundamental, bottom-up, company specific analysis, the Fund aims to invest in financial technology companies and/or companies where the key growth driver is to provide or use technology to deliver the next generation of financial services (FinTech).

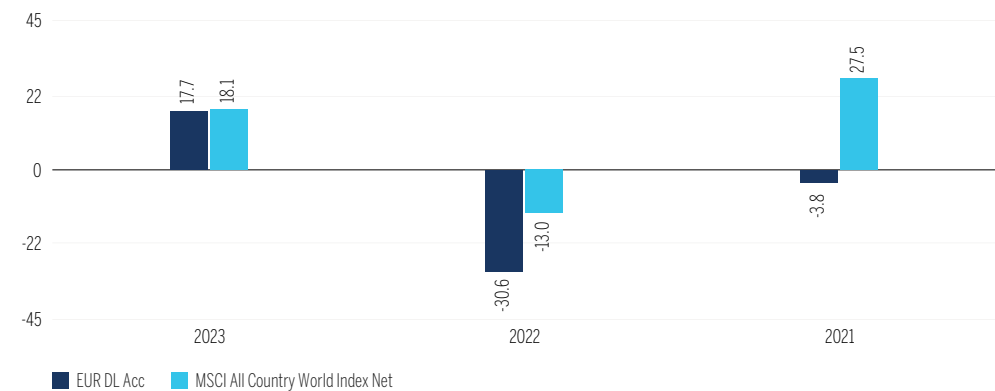

**WHAT ARE THE RISKS?**

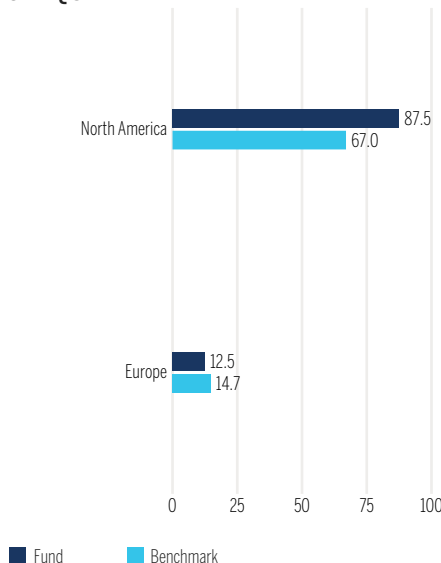

**REGIONAL DISTRIBUTION**

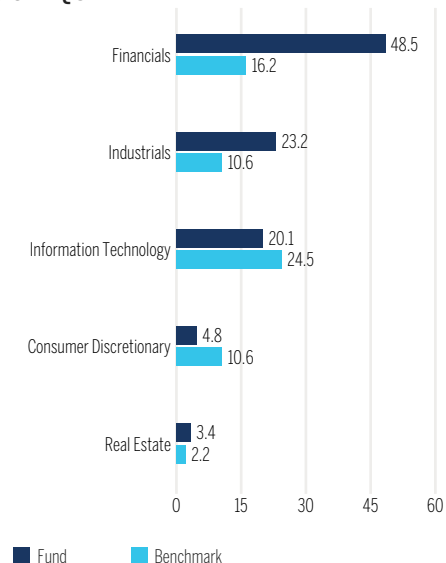
**% OF EQUITY**
