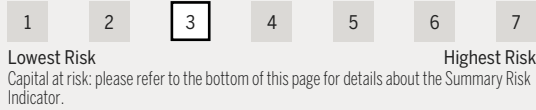

The Investment Manager will actively manage the Fund against a blended index of 50% JPMorgan Emerging Market Bond Index - Global Diversified and 50% JPMorgan Government Bond Index - Emerging Markets Global Diversified, seeking to achieve the objective by investing primarily in a diversified portfolio of US Dollar and local currency denominated emerging markets debt securities and currency instruments.

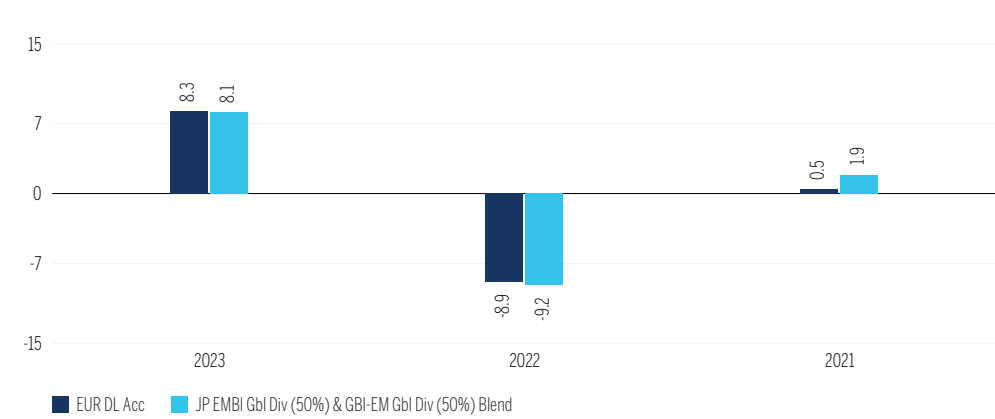

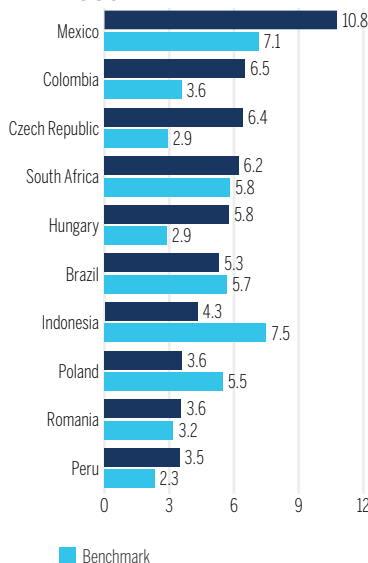

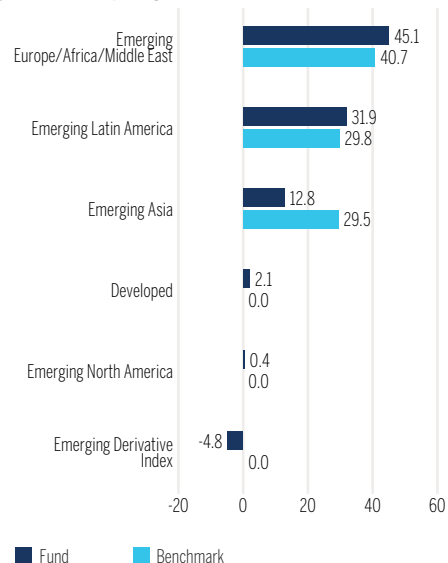
TOP 10 MARKETS

REGIONAL DISTRIBUTION

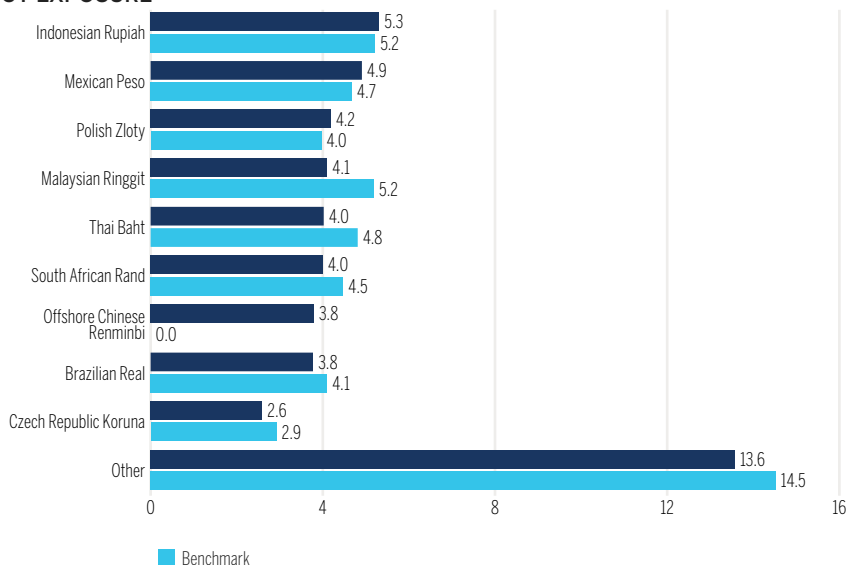
% MARKET VALUE
