

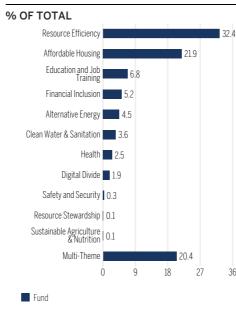



THEME DISTRIBUTION



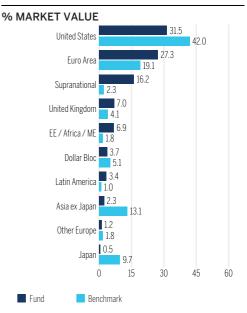

GEOGRAPHIC DISTRIBUTION



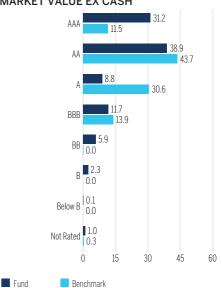
