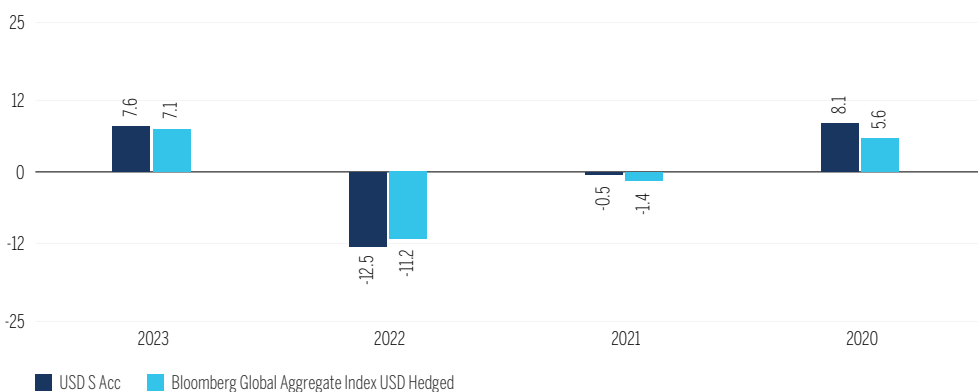

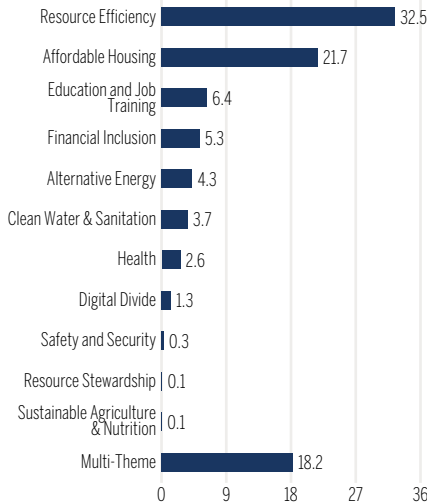

**THEME DISTRIBUTION**

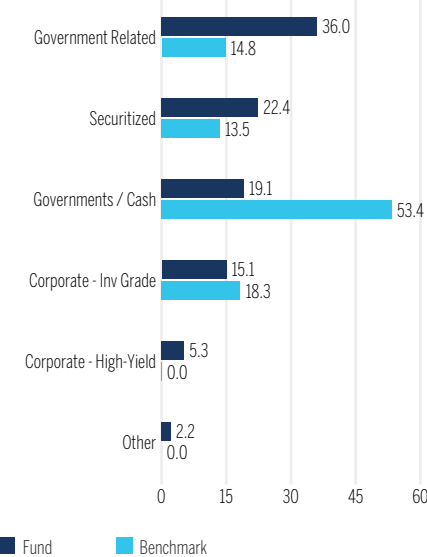

**SECTOR DISTRIBUTION**

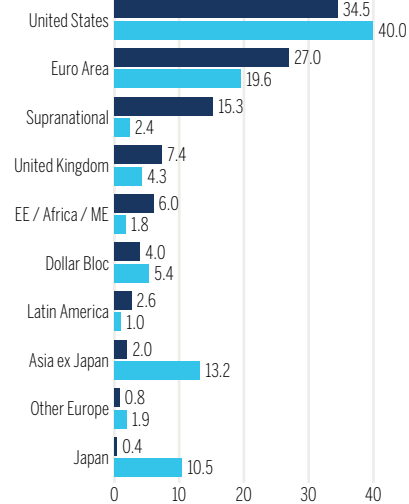
**% MARKET VALUE**

**GEOGRAPHIC DISTRIBUTION**

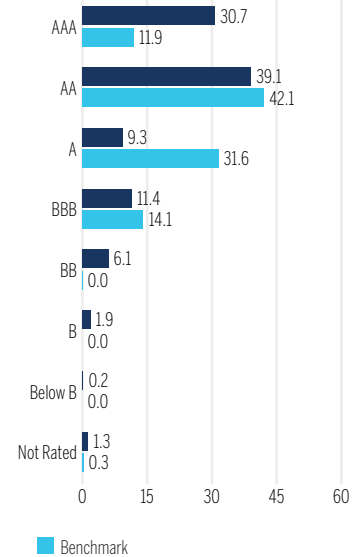
