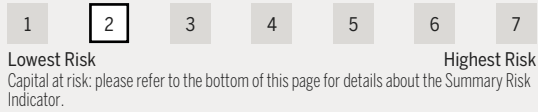

The Fund seeks to improve access to, and the quality of, basic life essentials, reduce inequality and mitigate the effects of climate change.

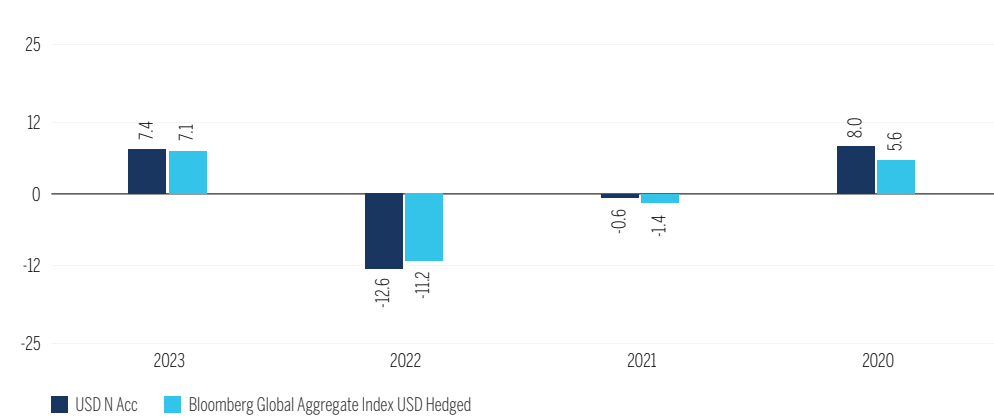

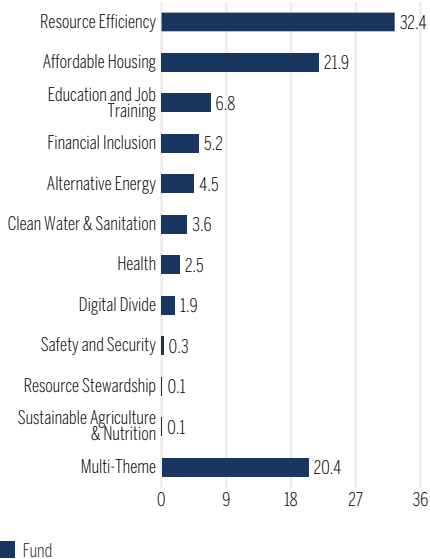

THEME DISTRIBUTION

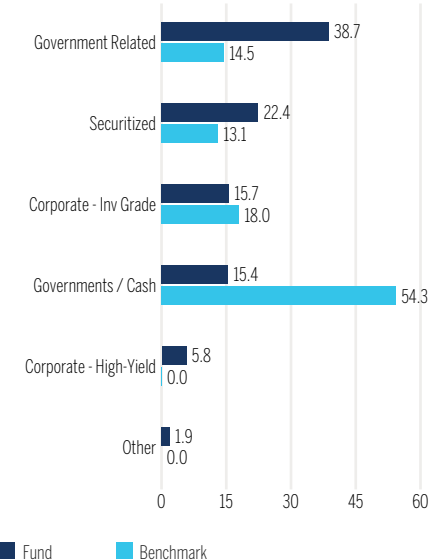

SECTOR DISTRIBUTION

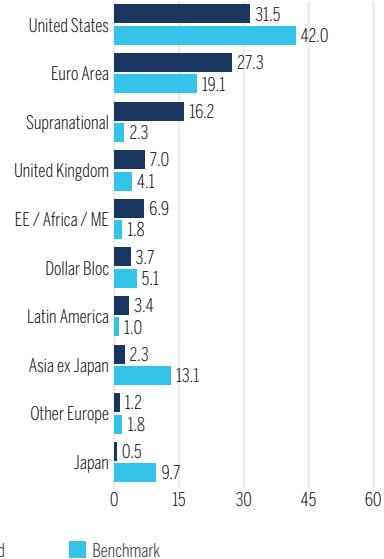
% MARKET VALUE

GEOGRAPHIC DISTRIBUTION

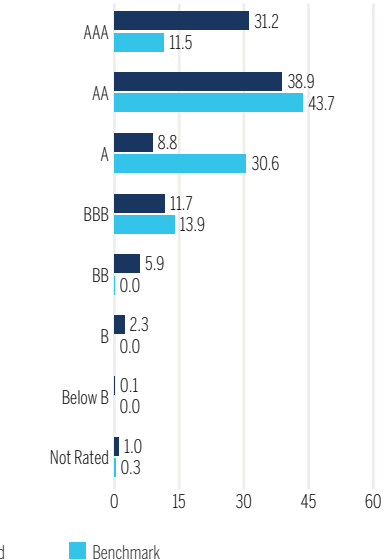
