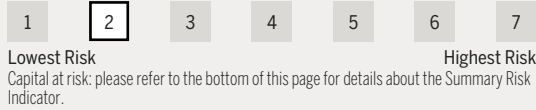

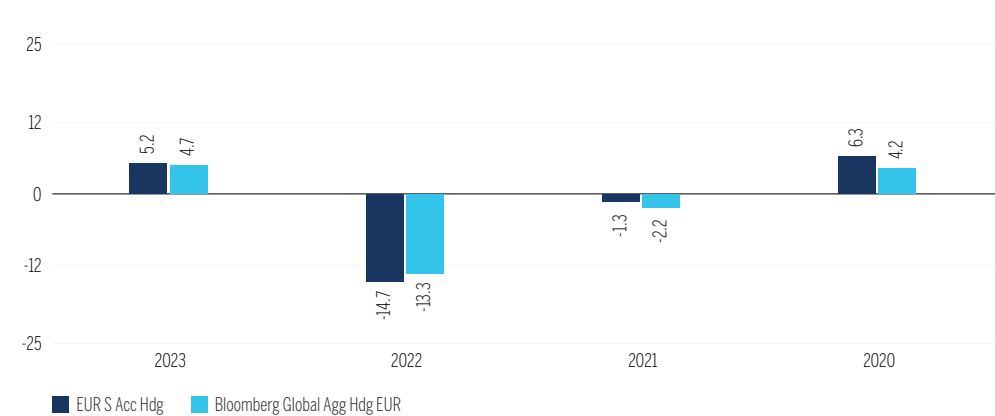

WHAT ARE THE RISKS?

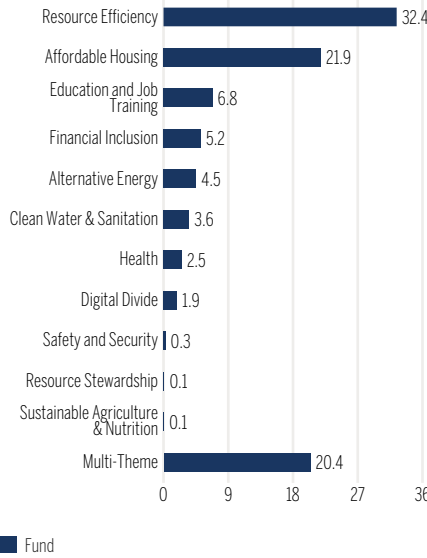

THEME DISTRIBUTION

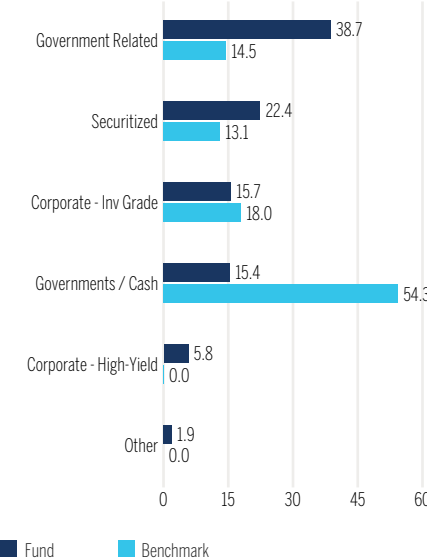

SECTOR DISTRIBUTION

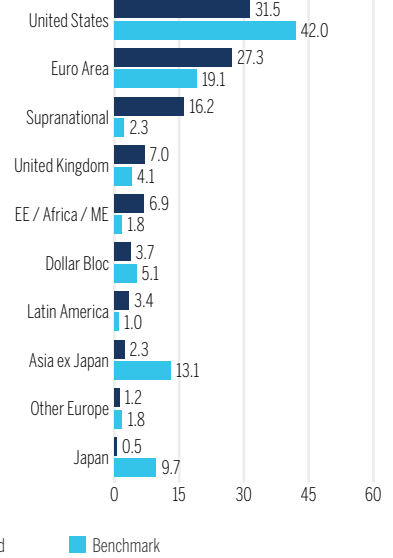
% MARKET VALUE

GEOGRAPHIC DISTRIBUTION

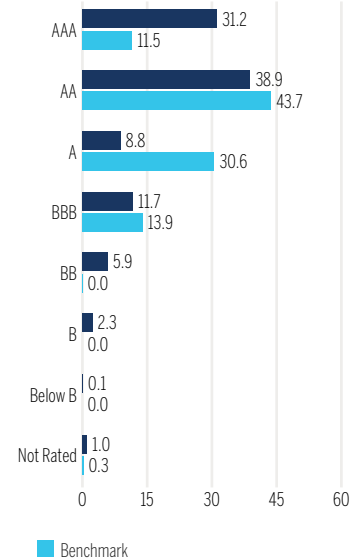
