



THEME DISTRIBUTION





GEOGRAPHIC DISTRIBUTION



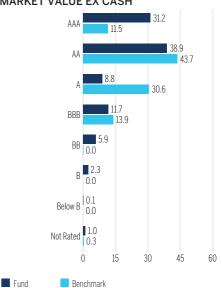
