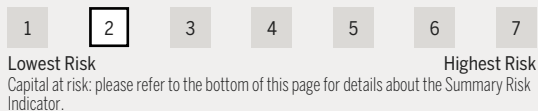

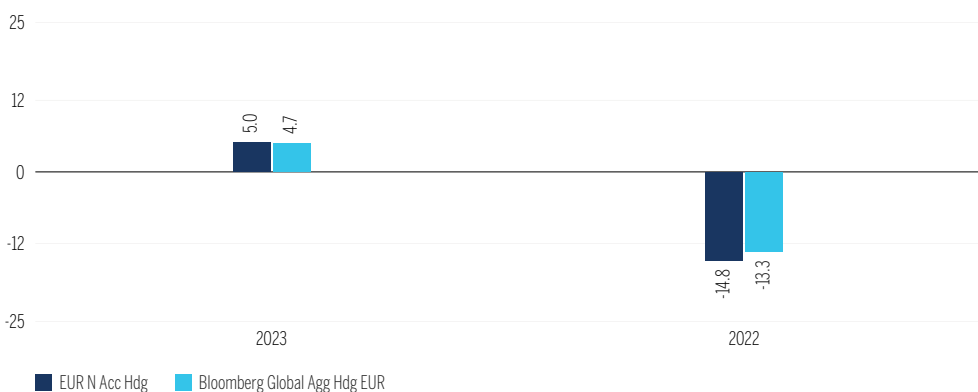

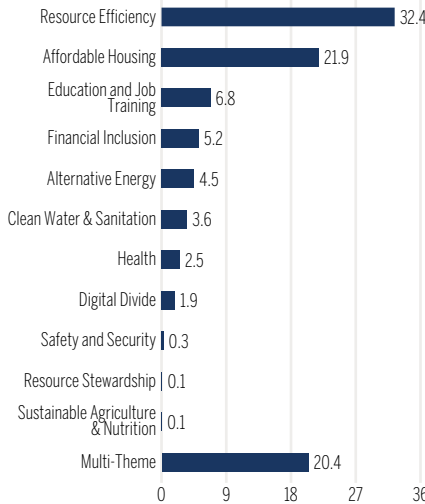

THEME DISTRIBUTION

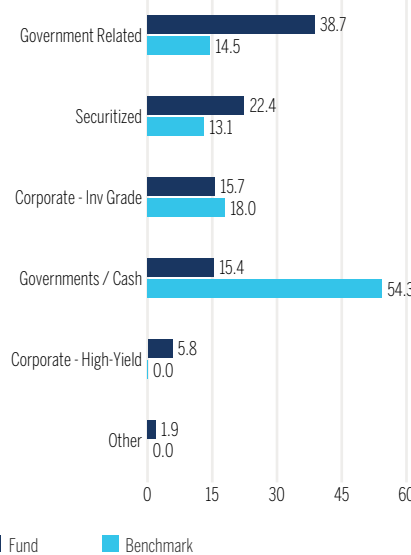

SECTOR DISTRIBUTION

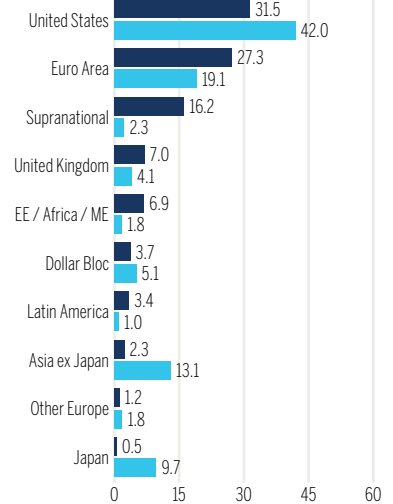
% MARKET VALUE

GEOGRAPHIC DISTRIBUTION

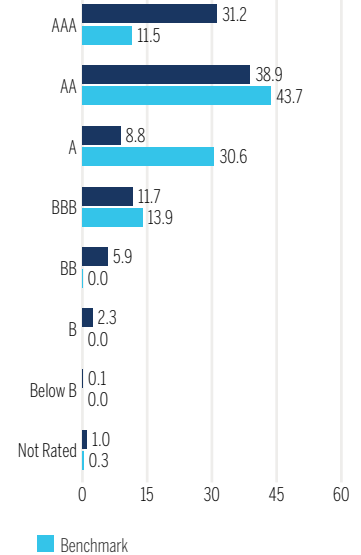
