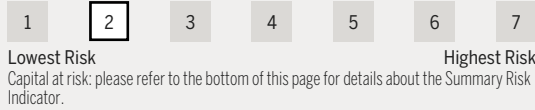

The Fund seeks to improve access to, and the quality of, basic life essentials, reduce inequality and mitigate the effects of climate change.

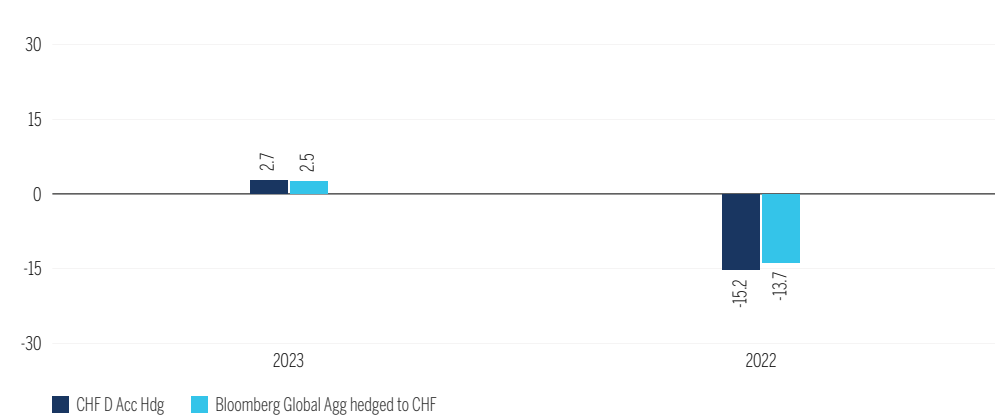

WHAT ARE THE RISKS?

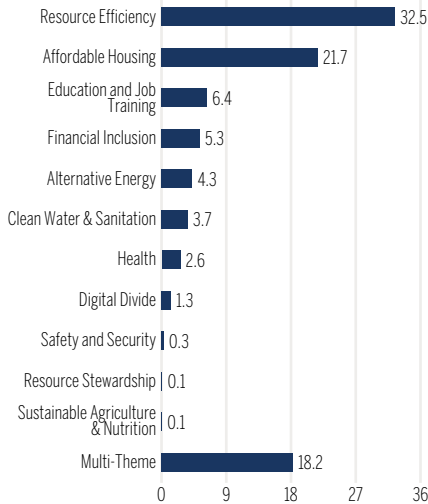

THEME DISTRIBUTION

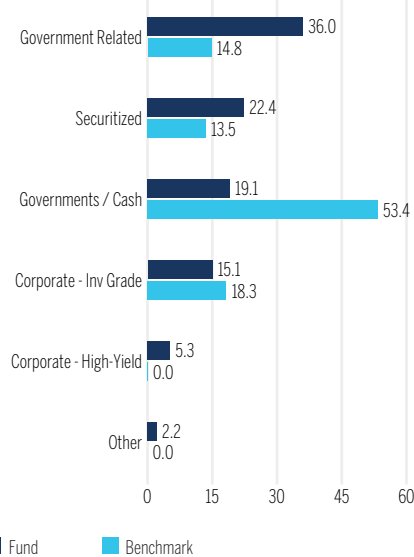

SECTOR DISTRIBUTION

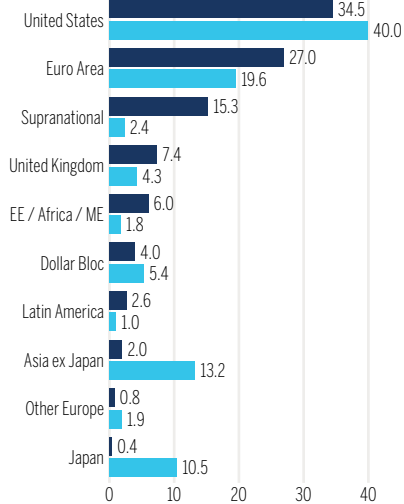
% MARKET VALUE

GEOGRAPHIC DISTRIBUTION

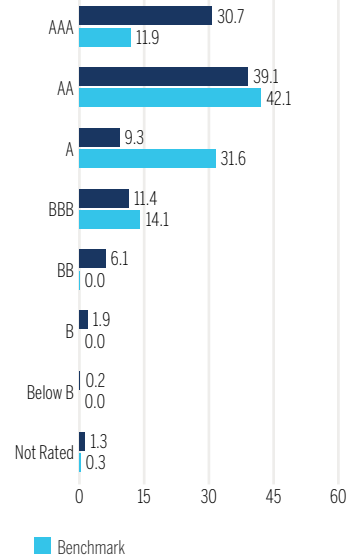
