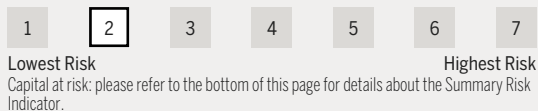

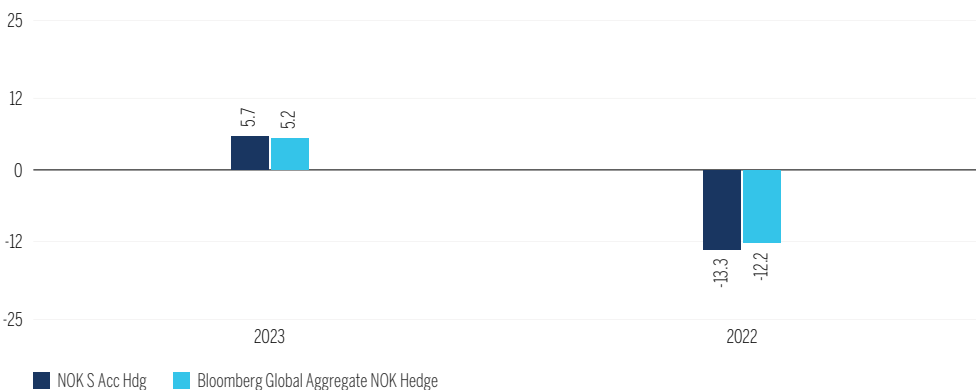

**WHAT ARE THE RISKS?**

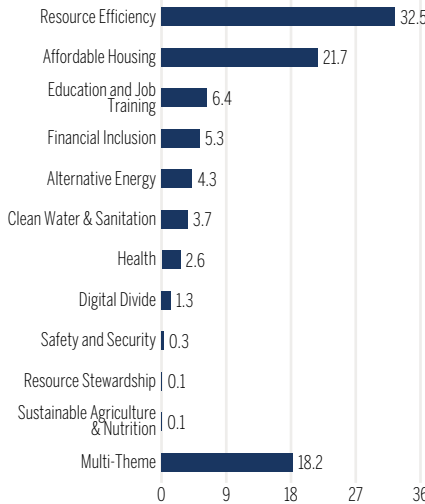

**% OF TOTAL**

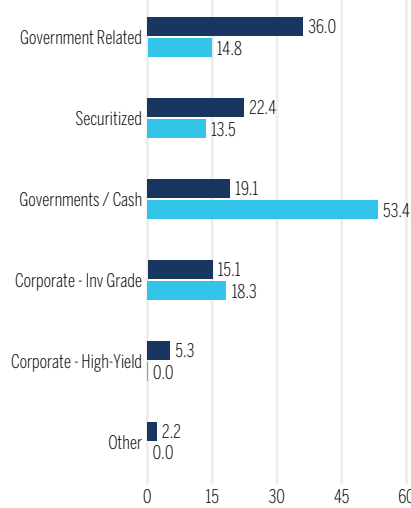

**% MARKET VALUE**

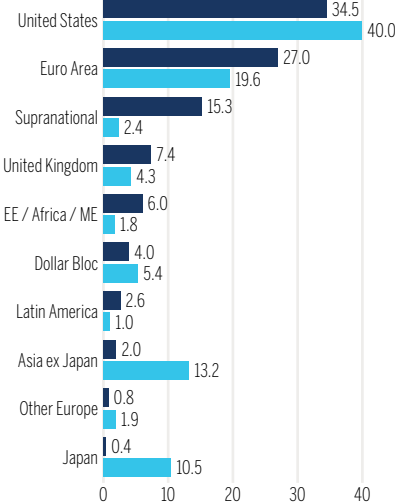

**% MARKET VALUE**



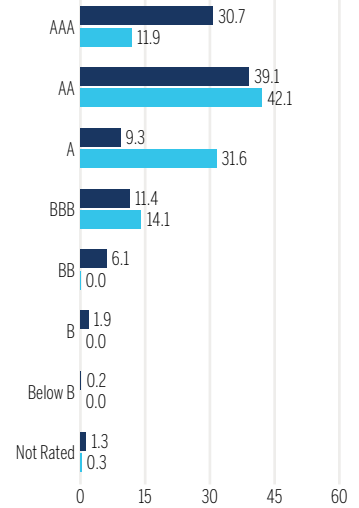
