#### Investment focus

The fund's objective is to generate consistent absolute returns of 5-7% p.a. in any market environment with an annualized volatility around 5-7%. The fund is actively managed and invests globally in several asset classes with the possibility to build up long and short exposure, maintaining a constant level of risk over time. A proprietary global macro screening engine supports an experienced team of specialists to express their market views and to define the most successful top down strategies. Risk is an integrated part within the entire investment process. By targeting an explicit risk level on a daily basis the risk profile is maintained over time. The portfolio is mainly invested in liquid assets, the fund offers daily liquidity. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



#### Market review

The fund returned 1.2% in September with a volatility of 2.3%. During the month, the MSCI World Equity Index gained 1.4%, the Bloomberg Global Aggregate Government index increased 0.9% and commodities lost 0.2%, all in euro hedged terms.

This month's contributors to the fund performance were equities 0.42%, non-government bonds 0.30%, government bonds 0.28% and gold 0.21%. The market was supported by the Fed, which indicated a shift towards focusing on the economy as inflation appears to be under control. Gold saw a notable increase of 4.48% in EUR, hitting new record highs. Within equities, Chinese technology stocks contributed the most. Non-government bonds were underpinned by the Coco and emerging market bond positions. Government bonds benefited from a 12 bps drop in the US 10-year treasury yield to 3.8%. During the month, we increased the equity allocation from 12% to 14% to capture market gains though we remain cautious due to high valuations, market concentration and deteriorating fundamentals. The allocations to long-term government bonds (25%) and to non-government bonds (36%) were unchanged. The total portfolio duration was maintained stable at 2.8 years vs the long-term average of 3.7 years. The main hedges of the fund are the 25% long-term government bond, the 19% USD and the 5% gold exposures.

#### **Positioning & outlook**

This month, we maintained the scenarios as follows:

Scenario 1, weight of 30%: The Fed and the ECB achieve a soft economic landing, the BoJ delays interest rate hikes and the Chinese government takes further steps to improve future prospects. Inflation continues to fall albeit at a slower pace. Still good corporate earnings, lower interest rates and improved sentiment on the Chinese economy fuel another leg in the equity rally. This is also positive for credit, neutral for government bonds and negative for the USD.

Scenario 2, weight of 50%: The US economy drifts into a mild recession. Several mitigating factors are likely to dampen the equity market correction and result in a mild loss of 5% to 15%: liquidity is still abundant, central banks will be able to lower interest rates and the boom in Al-related investments continues. This scenario is negative for credit and slightly positive for government bonds.

Scenario 3, weight of 20%: Developed economies fall into a global recession as interest rates remain high. Inflation persists and the Fed's restrictive monetary policy starts to impact the economy. Equity and credit markets correct. This is positive for government bonds, the USD and potentially gold.
