#### Investment focus

The fund's aim is to achieve capital growth in the long term, is actively managed and invests in global healthcare companies with innovative business models. Its investment universe consists of biotechnology and pharma companies, medical technology and services companies as well as generics producers that are involved in the development, manufacturing or sale of products and services. Experienced sector specialists focus on profitable companies that have a well-established product portfolio. The fund invests top down in the four regions North America, Western Europe, Emerging Markets and Japan/Oceania. For each of these regions, the most attractive companies are determined based on quantitative and qualitative criteria. The fund seeks to outperform the MSCI World Healthcare Index. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



#### Market review

MSCI World Healthcare outperformed MSCI World in August 2024 by 285 bps (MSCI World Healthcare +5.5% vs MSCI World +2.6%). Mixed US economic data combined with large movements in the Japanese yen led to high volatility especially in the beginning of the month. The Bellevue Healthcare Strategy (Lux) Fund (I-shares: +5.1%, in USD) underperformed (by 35 bps) its healthcare index benchmark. A broader geographic exposure, and lower exposure to ytd winners, proved to be a headwind in the month.

Around the middle of the month, US CPI data showed further stabilized inflation in conjunction with more dovish comments by Fed president Jerome Powell indicating that time has come to cut rates. The combination of these events drove a strong recovery within equity markets. Large-cap names and mega cap rallied with small caps almost moving as strongly. Later in the month especially new orders came in light and big tech names like Nvidia could not live up to expectations despite beating consensus numbers.

Within the MSCI World Healthcare Index, pharmaceuticals (+8.3%) was the best performing subsector in the month. This was followed by medtech (+7.4%), biotechnology (+3.0%), HC services (+2.2%), with lifesciences tools being the clear laggard with a negative performance (-1.2%).

From a geographical point of view, the performance of the regions was pretty homogenous. The European healthcare (+6.2%; MSCI European healthcare) performed best, followed by Asia healthcare (+6.03%; all country) supported by another strong month for Japanese equities. This was followed by Emerging Markets healthcare (+5.8%; all country), and lastly US healthcare (+5.2%; MSCI US healthcare).

Within the fund, strong absolute performances were reported during the month from Penumbra (+21.1% in USD, strong sales and earnings beat), Eli Lilly (19.5%; announced strong Q2 results), and Asahi Intecc (+16.0%; upbeat results). On the other hand, negative absolute performances were seen for Chongqing Zhifei Biologics (-14.6%; China healthcare weakness), Cochlear (-9.5%; delay in tenders), and McKesson (-9.0%; revenue miss).

#### **General description**

The investment process for the Bellevue Healthcare Strategy Fund resembles the rulesbased investment process that Bellevue has successfully applied since 2007. In this approach, the 45 most attractive stocks in the healthcare sector worldwide are selected every six months. The Bellevue Healthcare team screens about 700 of the 4000 listed companies in the healthcare sector worldwide based on four quantitative criteria (PEG valuation, price/sales, sales growth and EBITDA/sales) and four qualitative criteria (assessing the company's management, product pipeline, operating risks and country-related risks). The ten most promising stocks from four different regions - Western Europe, North America, Japan/Australia and emerging markets – are selected. The maximum weighting of the region with the highest overall score, which is usually North America, is capped at 35% during the periodic rebalancing, which increases the emphasis given to emerging markets. Companies with rich valuations and low growth rates will rarely be selected for the portfolio. Mid cap stocks have typically represented 60-80% and the Asia region approximately onethird of the portfolio. Pharmaceutical stocks are clearly underweighted compared to the MSCI World Healthcare Index. Bellevue has applied this investment approach since April 2007 and it is used to compile the Adamant Global Healthcare Index.

# **Adamant Global Healthcare Index**

The index is the property of Bellevue Asset Management and it is calculated by Standard & Poor's on a daily basis in CHF, EUR and USD.




