#### Investment focus

The fund's aim is to achieve capital growth in the long term, is actively managed and invests in global healthcare companies with innovative business models. Its investment universe consists of biotechnology and pharma companies, medical technology and services companies as well as generics producers that are involved in the development, manufacturing or sale of products and services. Experienced sector specialists focus on profitable companies that have a well-established product portfolio. The fund invests top down in the four regions North America, Western Europe, Emerging Markets and Japan/Oceania. For each of these regions, the most attractive companies are determined based on quantitative and qualitative criteria. The fund seeks to outperform the MSCI World Healthcare Index. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



#### Market review

MSCI World Healthcare underperformed MSCI World in October 2024 by 284 bps (MSCI World Healthcare -4.8% vs MSCI World -2.0%). A raising 10-year US treasury yield, mixed company Q3 results, and uncertainty into the US election saw global equities pull back in October. The Bellevue Healthcare Strategy (Lux) Fund (I-shares: -4.6%, in USD) outperformed (by 20 bps) its healthcare index benchmark.

Along with disappointing price action, we note that the forward P/E relative for MSCI World Healthcare versus MSCI World moved deeper into discounted territory in October. We see two drivers for this de-rating, healthcare was pulled into the US election volatility (mainly in healthcare services), and the mega-cap obesity names faced emerging (albeit early) competition risk.

Within the MSCI World Healthcare Index, healthcare tech (+0.5%) was the best performing subsector in the month. This was followed by biotech (-1.0%), medtech (-2.9%), and pharmaceuticals (-5.0%). Life science tools was the clear laggard with a performance of -9.9%. From a geographical point of view, Asian healthcare (all country, -3.6%) performed best, supported by a less weak performance for Japanese equities relative to global healthcare. This was followed by US healthcare (-4.6%), and European healthcare (-6.4%). The laggard region in October was Emerging Market Healthcare (all country, -7.1%), as the Chinese equity market retracted following a strong prior month.

Within the fund, strong absolute performances were reported during the month from Penumbra (+11.3%; strong Q3 results), Otsuka Holdings (+10.4%; complete nephrology Phase III study, and strong Q3 results), and UCB (+6.1%; continued strong prescription data for launch products). On the other hand, negative absolute performances were seen for Hygeia Healthcare (-24.0%; retraction in the Chinese market after strong September), Hypera (-18.8%; proposed merger deal volatility), and Regeneron (-20.3%; launch of Eylea biosimilar).

#### **General description**

The investment process for the Bellevue Healthcare Strategy Fund resembles the rulesbased investment process that Bellevue has successfully applied since 2007. In this approach, the 45 most attractive stocks in the healthcare sector worldwide are selected every six months. The Bellevue Healthcare team screens about 700 of the 4000 listed companies in the healthcare sector worldwide based on four quantitative criteria (PEG valuation, price/sales, sales growth and EBITDA/sales) and four qualitative criteria (assessing the company's management, product pipeline, operating risks and country-related risks). The ten most promising stocks from four different regions - Western Europe, North America, Japan/Australia and emerging markets – are selected. The maximum weighting of the region with the highest overall score, which is usually North America, is capped at 35% during the periodic rebalancing, which increases the emphasis given to emerging markets. Companies with rich valuations and low growth rates will rarely be selected for the portfolio. Mid cap stocks have typically represented 60-80% and the Asia region approximately onethird of the portfolio. Pharmaceutical stocks are clearly underweighted compared to the MSCI World Healthcare Index. Bellevue has applied this investment approach since April 2007 and it is used to compile the Adamant Global Healthcare Index.

### **Adamant Global Healthcare Index**

The index is the property of Bellevue Asset Management and it is calculated by Standard & Poor's on a daily basis in CHF, EUR and USD.




