#### Investment focus

The fund's aim is to achieve capital growth in the long term, is actively managed and invests in global healthcare companies with innovative business models. Its investment universe consists of biotechnology and pharma companies, medical technology and services companies as well as generics producers that are involved in the development, manufacturing or sale of products and services. Experienced sector specialists focus on profitable companies that have a well-established product portfolio. The fund invests top down in the four regions North America, Western Europe, Emerging Markets and Japan/Oceania. For each of these regions, the most attractive companies are determined based on quantitative and qualitative criteria. The fund seeks to outperform the MSCI World Healthcare Index. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.

#### Market review

MSCI World Healthcare underperformed MSCI World in September 2024 by 481 bps (MSCI World Healthcare -3.0% vs MSCI World +1.8%). A resilient US economy in combination with Fed rate cuts drove US equity markets to all-time highs. Cyclical sectors benefited from the strong US economy (e.g. consumer discretionary), while Fed cuts drove support for the higher yielding sectors (e.g. utilities). With a lack of support from either of these drivers, and some fundamental headwinds for key stocks, the healthcare sector underperformed. The Bellevue Healthcare Strategy (Lux) Fund (I-shares: -2.5%, in USD) outperformed (by 44 bps) its healthcare index benchmark. A broader geographic exposure, and lower exposure to ytd winners, proved to be a tailwind in the month. After broadly inline inflation data and strong labour data early in the month, the Fed surprised by cutting the base rate by 50 bps. The US economy continued to surprise to the upside on various metrics through September, supporting a goldilocks scenario for equities. Towards the end of the month, China stimulus drove a rally in Chinese mainland and Hong Kong-listed stocks. Within the MSCI World Healthcare Index, medtech (+1.3%) was the best performing subsector in the month. This was followed by life science tools (+1.1%), healthcare tech (+0.9%), biotech (-2.7%), with pharmaceuticals being the clear laggard with a negative performance (-6.1%). From a geographical point of view, the Emerging Market healthcare (all country, +7.2%) performed best, supported by a strong month for China equities. This was followed by Asia healthcare (all country, -0.4%), US healthcare (+1.8%), and European healthcare (-6.1%). From a market-capitalization perspective, the mid caps (USD 2-60 bn mrk-cap; -0.6%) performed best supported by a size rotation mid-month. This was followed by the large caps grouping (USD 60-200 bn; -1.7%), with the mega cap grouping (>USD 200 bn; -4.9%) performing weakly (driven by Novo Nordisk; -15.4% in September). Within the fund, strong absolute performances were reported during the month from Chongqing Zhifei Biologica (+46.3% in USD; China stimulus + confidence in Gardasil growing), Hygeia Healthcare (+21.6%; China stimulus), and Pro Medicus (+21.1%; continued positive metrics). On the other hand, negative absolute performances were seen for Daiichi Sankyo (-21.0%; negative clinical trial update), Novo Nordisk (-15.4%; negative clinical trial update), and Aspen Pharmacare (-14.7%; disappointing FY results).

## **General description**

The investment process for the Bellevue Healthcare Strategy Fund resembles the rulesbased investment process that Bellevue has successfully applied since 2007. In this approach, the 45 most attractive stocks in the healthcare sector worldwide are selected every six months. The Bellevue Healthcare team screens about 700 of the 4000 listed companies in the healthcare sector worldwide based on four quantitative criteria (PEG valuation, price/sales, sales growth and EBITDA/sales) and four qualitative criteria (assessing the company's management, product pipeline, operating risks and country-related risks). The ten most promising stocks from four different regions - Western Europe, North America, Japan/Australia and emerging markets - are selected. The maximum weighting of the region with the highest overall score, which is usually North America, is capped at 35% during the periodic rebalancing, which increases the emphasis given to emerging markets. Companies with rich valuations and low growth rates will rarely be selected for the portfolio. Mid cap stocks have typically represented 60-80% and the Asia region approximately onethird of the portfolio. Pharmaceutical stocks are clearly underweighted compared to the MSCI World Healthcare Index. Bellevue has applied this investment approach since April 2007 and it is used to compile the Adamant Global Healthcare Index.

#### **Adamant Global Healthcare Index**

The index is the property of Bellevue Asset Management and it is calculated by Standard & Poor's on a daily basis in CHF, EUR and USD.




