#### **Market review**

Major indexes tacked on more gains last month. The MSCI World Index closed 2.7% higher month-on-month in USD. It seems like a Goldilocks scenario has taken center stage again. Economic data in the US suggests that economic activity, household consumption in particular, is holding up well without any signs of overheating. That, in turn, should not put any upward pressure on inflation. In the speech he gave at Jackson Hole, Fed Chair Jerome Powell flagged an initial rate cut for September 18, when the Fed's policy-making committee holds its next meeting. The market was also generally pleased with the latest company news, although some tech stocks were not quite as hot as in previous quarters, especially after making statements about their business outlook. Healthcare performed much better than the total market thanks not least to strong quarterly results from large-cap health stocks. The MSCI World Healthcare Index closed 5.5% higher mom. Emerging market healthcare stocks performed even better, fueled once again by a surge in Indian and South Korean equities.

Chinese healthcare stocks also made pleasing gains, driven in part by strong quarterly results. Investors cheered the fast sales growth at Innovent, one of the fund's largest positions. Product sales revenue soared 55% in the latest quarterly reporting period compared to the same quarter in the previous year. Its checkpoint inhibitor approved in China as a treatment for numerous types of cancer was a major driver of this growth. Phase III data for its obesity drug is keenly awaited. Innovent is expected to release the data at the European Association for the Study of Diabetes (EASD) in September.

A large number of Chinese healthcare companies reported on business activity in the past quarter during the month under review and many medtech, generics and hospital companies conspicuously fell short of expectations. It appears that the extensive anti-corruption campaign the government launched last August is still casting a shadow over these subsectors within the healthcare system and has clearly put a damper on market activity. Contract manufacturers are also encountering headwinds due to geopolitical tension, so we have realigned our shareholdings in China again and sharpened the focus on innovation, especially in biotechnology.

The latest results from Hapvida, a fully integrated Brazilian healthcare provider, topped market expectations. The company increased EBITDA by 55% yoy, which was about 15% above the consensus forecast. The strong performance was largely attributed to strict cost management and synergies arising from the company's fully integrated business model. Higherthan-expected tax expense was the only fly in the soup.

Fund positions in Alteogen, SK Biopharmaceuticals, Sino Biopharmaceuticals and Celltrion were increased last month and Kalbe Farma was added to the portfolio. Shareholdings of CSPC, Mindray, Sinopharm and Shandong Weigao were reduced and two positions were closed, Hygeia and Aier Eye Hospitals.

#### **Positioning & outlook**

The fastest growing countries in the world can be found in emerging markets, and they contain more than half of the world's population. Asian emerging markets are also forecast to account for more than 50% of global GDP by 2050. It is known that the economic growth model of countries shifts from manufacturing to the services sector as household incomes rise. A growing middle class fuels demand for modern medicine. Healthcare ranks increasingly high on their wish list. Billions are being invested in infrastructure, technology, and research to modernize the healthcare systems in emerging market countries. This is giving a greater swath of the population access to better healthcare. Meanwhile, rapid population aging is also stoking demand for healthcare. In 30 years, there will be 400 to 500 mn people over 60 in China alone, and they will have a growing need for modern health services and medicines. Outside Asia, Brazil's rapidly expanding private-sector healthcare market offers a range of interesting investment opportunities. The quality and long waiting times of the country's public health system are no longer acceptable to many higher-income Brazilian households, and they are increasingly embracing these new services offered by privatesector healthcare providers. Hospital chains embedded in a fully-integrated ecosystem are but one example of the beneficiaries of this structural change. The fund serves as a defensive vehicle for capturing the above-average growth potential emerging markets offer. It invests in the entire healthcare system value chain, from hospital chains, drug developers and device manufacturers to medical research specialists and digital health companies.
